On April 8, 1998, the NRC administered a generic fundamentals examination (GFE) section of the written operator licensing examination to employees of your facility. Enclosed with this letter are copies of both forms of the examination, including answer keys, the grading results for your facility, and copies of the individual answer sheets for each of your employees. Sixteen individuals were administered the examination. Fifteen passed the examination and one individual failed the examination. Please forward the results to the individuals along with the copies of their answer sheets. A "P" in the column labeled RESULTS indicates a passing grade of 80 percent or better on the GFE. Those individuals having an "F" in the RESULTS column failed the examination.


