- (4) all justifications for awarding the contract to Pilot, including any test reports, evaluations or analyses comparing Pilot's products to other products;
- (5) any contracts or purchase orders awarded to any concern for the purpose of evaluating software products offered in connection with the subject procurement;

- (9) any inspection reports or acceptance reports issued by the NRC under the Pilot contract; and
- (10) any invoices submitted by Pilot.


