Dear Dr. Patrick:

The purpose of this modification is to extend the period of performance through September 30, 1998, at no additional cost or obligation to the Government, to allow the contractor additional time to complete the review of Energy Fuels Nuclear, Inc., White Mesa Mill, Blanding, UT reclamation plan. The additional time is required to respond to the licensee's detailed technical licensee review. This may require subsequent rounds of requesting additional information from the licensee, in addition to preparing the draft and final Technical Evaluation Report. Accordingly, the contract is hereby modified as follows:

The first sentence, second paragraph of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 17 shall be in effect from June 16, 1997 through September 30, 1998 with a cost ceiling of \$67,922."




