Thank you for your March 14, 1989 response regarding off-hour inspections at the Cintichem Reactor Facility. Upon discussing your response with members of the TRTR Executive Committee and with the Cintichem management, we have no further concerns on this matter, realizing that since the action taken at that facility was based on its fuel facility license and not its reactor license other non-power reactors will not be subject to similar inspection practices.


We would like to meet with you to discuss two other items that are of current concern to the non-power reactor community. The first issue deals with the severity of enforcement actions imposed on non-power reactors. In the recent past we have seen harsh enforcement actions, including the imposition of fines, which appear to be more severe than necessary to restore full compliance with regulatory requirements at the facility in question and to assure the pursuit of excellence in the operation of other facilities. We are not aware of a general lack of responsiveness on the part of licenses that warrants measures so severe.

The second issue involves the limitation of non-power reactor expertise and experience within the Commission. We find that our facilities are increasingly being evaluated against criteria applicable only to power reactors by personnel whose expertise is primarily that of power reactors. We would like to seek ways of increasing the sensitivity within the Commission to the unique aspects of non-power reactor operations.
