Dear Ms. Delisio:

This refers to your letter dated May 22, 1998, describing the proposed transfer of your licensed activities to Navix Radiology Systems, Inc.. 
Summary: Licensee's letter informing NRC about the transfer of ownership included a statement that implied that the name of the licensee is to be changed.

Dear Ms. Henderson:

NMC Diagnostic Services, Inc. (NMC) is hereby notifying you of the intent to sell all assets to Navix Radiology Systems, Inc. (Navix) on or about June 9, 1998. The change of ownership of assets will include the **materials licenses 29-30171-01 and 29-30171-02.**

In response to the information necessary for change of ownership as directed in the NRC Information Notice 89-25, we submit the following information:

1. The new name of the licensed organization will be Navix Radiology Systems, Inc.
2. Licensee contact person for Materials License No: 29-30171-01 and 29-30171-02: will continue to be Terry Day, telephone number 609-786-4799. If and when changes are made to the above information, the NRC will be promptly notified.
3. There will be no changes in personnel having control over licensed activities, including respective Radiation Safety Officer(s) and authorized users for each Materials License.
4. The transferor, NMC, will not remain in non-licensed business without the license.
5. The acquisition transaction is an asset purchase.
6. Changes will be in ownership only. Facilities where licensed materials are used will remain unchanged in location, equipment and procedures.
7. There will be no changes in the use, possession, location or storage of the licensed materials.

8. There will be no changes that would require a license amendment even without the change of ownership.
9. All surveillance items and records will be current at the time of transfer.
10. All records concerning the safe and effective decommissioning of facilities will be transferred to the transferee, Navix.
11. There is no contamination present at any of our facilities, therefore there are no plans for decontamination.
12. The transferee agrees to abide by all commitments and representations previously made to the NF C by the transferor.
13. The transferor and transferee agree to the change in ownership and control of the licensed material and activity, etc. There are no open inspection items on any of the material license(s).
14. The transferee commits to abide by all constraints, conditions, requirements, representations, and commitments identified in the existing licenses.
