This preliminary notification constitutes EARLY notice of events of POSSIBLE national security or public interest significance. The information presented is as initially received without verification or evaluation and is basically all that is known by IE staff as of this date.

Facility: Diablo Canyon Unit No. 1, DN. 50-275 Pacific Gas & Electric Company

Subject: BOMB THREAT

At 0833 March 31, 1977, the licensee reported by telephone to the Region V office the following:

At 1845 hours March 30, 1977 an unknown male called the Diablo Canyon switchboard and stated that an explosive device had been planted in Unit No. 1 and it would explode before midnight. At that time there were approximately 30-40 employees on site (excluding guard force). Employees were informed and given the option to leave. Six or seven employees did leave the site, the remaining employees and the guard force conducted a search of Unit No. 1. The search was completed by 2300 hours, March 30, 1977 with negative results and normal activities were resumed.

The licensee plans to notify the San Luis Obispo County Sheriff's Office today. The Oakland Office FBI was notified by Region V at 0940, March 31, 1977.

No press coverage has occurred and no press release is planned.

The IAT has been notified.
