Subject: POTENTIAL INGESTION OF 2.5 uC1 241 AMERICIUM SOURCE

On January 29, 1976, the licensee's consultant informed IE:III that a female employee for the licensee might have inadvertently swallowed a 2.5 uCi 241 Am source five to seven days ago. The source, a very thin foil approximately 1/16 inch square, consisted of americium oxide plated on a silver foil, which in turn was enclosed in a crimped gold foil. The employee notified her supervisor of the incident when it occurred, but the decision to notify NRC was not made until the return of the Company President on January 29, 1976. Employee has been admitted to Billings Hospital, where she is undergoing urine and fecal analysis and scanning procedures. Assuming normal elimination, the licensee estimates the dose not to exceed 4 rem.

There has been no press release by NRC or Pittway Corporation.
