In a letter dated June 17, 2020, the NRC acknowledged receipt of the pending transfer of control of NRC License No. 21-25833-01 to Northpointe Heart Center, P. C. (NPH) pending the expiration of the professional service agreement on October 31, 2020. Accordingly, on November 1, 2020, NPH will assume direct control of the activities and radioactive materials authorized under NRC License No. 21-25833-01 located at 27901 Woodward Ave., Ste. 300, Berkley, MI 48072.

Additional Information Requested: (NUREG-1556, Vol. 15, Rev. 1, Appendix E, Items 4, 6 – 8) Section 5

### 5.4 Surveillance Records

The applicable surveillance requirements and records including leak tests, area surveys, wipe tests, physical inventories, compliance audits, dosimetry, training, radioactive waste and disposal, and instrument calibration, and other quality control records are currently up to date and in accordance with NRC standards. The audits are conducted quarterly. The third quarter audit (ending September 30, 2020) will be completed consistent with NRC standards at the end of the quarter. A further review of the relevant surveillance records inclusive of October 31, 2020 will be performed to ensure compliance with NRC standards at the time of transfer of control to NPH on November 1, 2020. Dosimetry records for staff will not be available for October at the time of transfer.

### 5.5 Decommissioning and Related Records Transfer

There is currently no known contamination issue at this site, and no decommissioning is being planned. Current activities will continue until the transfer of control to NPH on November 1, 2020. All records will be transferred to NPH, who will assume custody. NPH will accept full responsibility for any future decommissioning at this site including any contamination of facilities and equipment.

### 5.6 Transferee's Commitment to Abide by the Transferor's Commitments

NPH will abide by all constraints, conditions, requirements, representations, and commitments contained in NRC License No. 21-25833-01. There are no known enforcement actions or investigations in regard to this license at this time.

Documentation that the transferee and the transferor agree to the change in ownership:

The legal documentation in regard to this transfer of control will be forthcoming. The signatures on this document are attestation to the ongoing agreement to the transfer of control for NRC License No. 21-25833-01 by NPH as indicated in our prior submission to this effect.

A signed and dated letter confirming that Richard E. Gordon, D.O. has received refresher training in the radiation safety, regulatory issues, and emergency procedures for use of 10 CFR 35.100 and 35.200 material in accordance with 10 CFR 35.50(d) accompanies this submission as requested.
