## AUDIT OF NRC'S INTEGRATED MATERIALS PERFORMANCE EVALUATION PROGRAM

(OIG-20-A-10)

## Status of Recommendation

Recommendation 1:

Finalize existing IMPEP guidance that addresses the organization, structure, and procedures to consistently implement NRC's consolidated IMPEP Program.

Agency Response Dated July 15, 2020 The NRC staff agrees with the recommendation and has already taken steps to address it. The following steps will be taken to address the recommendation:

- Complete the revision of the existing Interim State Agreement (SA) procedure, SA-100, "Integrated Materials Performance Evaluation Program" to include aspects of the implementation plan that align with the NRC consolidated IMPEP plan. The procedure will include aspects related to the organization and structure of the consolidated NRC IMPEP review (e.g., Regions and Divisions subject to IMPEP, IMPEP team composition, etc.)
- The comment period for the Interim SA-100 ended on July 1, 2020. NRC staff will incorporate comments into SA-100, as appropriate, and issue the procedure as final. The finalized procedure will be posted on the NRC's State Communication Portal under the Office of Nuclear Material Safety and Safeguards' procedures tab (https://scp.nrc.gov/procedures.html).

Target date for completion:
Complete action by October 2020

**OIG** Analysis:

The proposed actions meet the intent of this recommendation. This recommendation will be closed when OIG reviews the updated guidance to determine that the guidance (1) aligns with the NRC consolidated IMPEP plan, and (2) makes clear the organization and structure of the consolidated IMPEP review.
