Dear Mr. LaFranzo,

This letter is written to request a 90-day extension for submitting the relevant documentation for continued eligibility to the *“self-guarantee for providing reasonable assurance of funds for decommissioning”* for the Type A Broad Scope Radioactive Materials License (NRC Materials License 24-00167-11) as well as the Accelerator Production License (NRC Materials License 24-00167-14) issued to Washington University in St. Louis.

This request is being made in line with the April 7, 2020 US NRC Letter describing methods for providing regulatory relief during the coronavirus disease 2019 public health emergency.

Unfortunately, the impact of the Covid-19 Public Health Emergency has delayed the administrative completion of relevant documents related to the *“self-guarantee”* for NRC Materials Licenses 24-00167-14 and 24-00167-11, as described in 10 CFR 30, Appendix E, section II(C)(2).

Therefore, a 90-day extension is being requested to allow for satisfactory completion, compilation, and submission of the required documents to provide reasonable assurance of funds for decommissioning by Washington University in St. Louis.

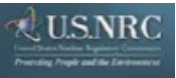
