This letter provides notification to the U.S. Nuclear Regulatory Commission (NRC) that operations pursuant to NRC Material License No. 24-24576-01 have been transferred in total from Alliant Techsystems Operations (ATO) to Olin Winchester, LLC (Winchester). The transfer of operations occurred after receipt of a "Letter of Consent for the Direct Change of Control" from the NRC, dated 11 September 2020. The transfer of operations was made effective 00:00, 1 October 2020, as documented in the enclosed Memorandum of Agreement between ATO and Winchester.

This letter also affirms that the transfer of operations occurred in accordance with Winchester's "Notification of Direct Change of Control and Request for Letter of Consent for NRC Material License No. 24-24576-01" provided to the NRC on 13 March, 2020, and in accordance with Winchester's response to the NRC's Request for Additional Information provided to the NRC on 22 July, 2020. As such, the source, programs, procedures, and personnel associated with this license have not changed. No changes have been made to the facility, equipment, radiation safety or training programs associated with the license, and the RSO will continue to be Rick Thompson. Both the transferor and transferee agree to transferring control of the licensed material and activity and the conditions of the transfer.

Based upon the successful transfer of operations, a request is hereby made to amend NRC Material License No. 24-24576-01 to revise the licensee name and address as:



Memorandum of Agreement between Alliant Techsystems Operations, LLC and Olin Winchester, LLC Regarding the Transfer of Operations at the Lake City Army Ammunition Plant

This memorandum of agreement affirms that a transfer of possession of radioactive materials and responsibility for the implementation of radiation protection and control activities and operations pursuant to NRC Material License No. 24-24576-01 has occurred. The transfer of operations from Alliant Techsystems Operations (ATO) to Olin Winchester, LLC (Winchester) was completed and made effective 00:00, 1 October 2020. Winchester has taken possession and control of the radioactive materials identified in the license and has assumed control of and responsibility for the radioactive materials program. Rick Thompson will remain at the Lake City Army Ammunition Plant as the Winchester Radiation Safety Officer, thus transferring his role and employment from ATO to Winchester.
