Dear Ms. Gepford:

The purpose of this letter is to provide the 30-day notification required by 10 CFR 35.14(b) concerning changes to the Radiation Safety Officer position named in NRC License Nos. 50-17838-01 (Providence Alaska Medical Center, PAMC) and 50-29357-01 (Providence Imaging Center, PIC). We call the following points to your attention regarding these changes:

- First, we are providing notification in accordance with 10 CFR 35.14(b)(1) that Dr. Mark Winslow, effective on 9/27/2020, is no longer serving as RSO for both of the above-mentioned licenses. Dr. Winslow will continue to be employed by the PAMC as the Authorized Medical Physicist under License No. 17838-01 and thus is available for consultation and transition to the next RSO.
- Second, we are providing notification in accordance with 10 CFR 35.14(b)(2) and 10 CFR 35.24(c) that Dr. Joseph F. Harmon is named as the temporary RSO for both of the above-mentioned NRC licenses under the provisions of 10 CFR 35.24(c). Dr. Harmon has served as an RSO in several facilities, most recently with the Alaska Cancer Treatment Center (NRC License No. 50-35123-01). We believe that based on his RSO and AMP experience, Dr. Harmon is eminently qualified to serve as our RSO in place of Dr. Winslow.
- Lastly, it is our understanding that licenses that are under timely renewal action by the NRC ordinarily cannot be amended or otherwise modified. The PIC license has been under timely renewal since the license expired on 10/31/2019. Hopefully, action can be taken soon on renewing the PIC license so that when we propose a permanent RSO, our request can be acted upon.
