Dear Mr. Smith:

This is in reference to your application dated September 29, 2020, requesting to terminate NRC License No. 47-31463-01. In order to continue our review, we need the following additional information:

Your NRC license authorizes the possession of up to 18 mCi of Cs-137 and 88 mCi of Am-241/Be for use in Troxler Electronic Laboratories Model 3400 Series portable gauging devices. However, your termination request included leak tests and transfer records for 27 mCi of Cs-137 and 132 mCi of Am-241/Be for use in Troxler Electronic Laboratories Model 3400 Series portable gauging devices. As such, please provide the following:

- a. Please provide a copy of your Pennsylvania Agreement State license.
- b. Please confirm which of the Troxler Model 3400 Series gauges were stored and utilized in NRC jurisdiction as opposed to PA Agreement State jurisdiction.
- c. FYI only No response required If the same information was provided to the PA Agreement State license reviewers, please consider providing updated information to their license reviewers to avoid duplicate requests for additional information.

We will continue our review upon receipt of this information. Please submit your response to <u>Jonathan.Pfingsten@nrc.gov</u>.

In order to continue prompt review of your application, we request that you submit your response to this letter within 10 calendar days from the date of this letter.
