Pursuant to the requirements of 10 CFR 50.54(p), Northern States Power Company-Minnesota (NSPM) doing business as Xcel Energy submits, Revision 13 of the Prairie Island Nuclear Generating Plant Security Plan, Training and Qualification Plan, Safeguards Contingency Plan (here after referred to as the Security Plan). The changes were effective on September 15, 2020.
