Subject: ACTION: Opportunity to review and comment on an NRC proposed information collection "Voluntary Reporting of Planned New Reactor Applications" (3150-0228)

The Nuclear Regulatory Commission recently published a Federal Register Notice announcing our intent to submit an information collection request to the Office of Management and Budget (OMB) for "Voluntary Reporting of Planned New Reactor Applications." As a potential respondent to this information collection, we are interested in your feedback. Specifically, we are seeking input on the following questions by February 1, 2021:

1. Is the proposed collection of information necessary for the NRC to properly perform its functions? Does the information have practical utility?
2. Is the burden estimate accurate?
3. Is there a way to enhance the quality, utility, and clarity of the information to be collected?
4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?
