This report documents the results of the information security inspection that was conducted at the Department of Energy, Idaho Operations Office, Willow Creek Building Room 240D in Idaho Falls, Idaho, on October 27, 2020, and at the Fort Saint Vrain (FSV) Facility site in Platteville, Colorado, on October 29, 2020. The purpose of this inspection was to determine whether activities authorized under the license were conducted safely, securely, and in accordance with Nuclear Regulatory Commission (NRC) requirements. The results of this inspection were discussed with members of your staff at an exit meeting held on November 23, 2020.

During the inspection, the NRC staff examined activities conducted under your license as they related to protection of classified matter and to confirm compliance with the Commission's rules and regulations, and with the conditions of your license. Areas examined during the inspection are identified in the enclosed report. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of the inspection, no violations of more than minor significance were identified.

The material enclosed herewith contains Security-Related Information associated with the Classified Information Security safeguards program for the FSV facility, and in accordance with Title 10 of the *Code of Federal Regulations* 2.390(d)(1), its disclosure to unauthorized individuals could present a security vulnerability.
