Dear Mr. Wissing:

Enclosed is Amendment No. 119 to your NRC Materials License No. 21-00943-03 in accordance with your request dated September 18, 2020.

Also enclosed is Amendment No. 65 terminating your NRC License No. 21-14849-01 in accordance with your request dated September 18, 2020. As part of the termination, the location of use at 36475 W. Five Mile Rd., Livonia, MI 48154, was transferred to NRC License No. 21-00943-03 in the aforementioned Amendment No. 119.

In your letter dated September 18, 2020, you requested that an area within the Livonia, MI location of use noted above be decommissioned and released. You provided a facility decommissioning report to support your request. The NRC staff has reviewed all of this information, including the final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the Radiation Oncology Lab (Room 105) at 36475 W. Five Mile Rd., Livonia, MI 48154, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release the Radiation Oncology Lab (Room 105) for unrestricted use.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The enclosed document contains sensitive security-related information.
