This office represents CH Allied Services, Inc., a Missouri nonprofit corporation d/b/a Boone Hospital Center (the "Hospital"). In this capacity, I am writing to provide a courtesy notice that effective January 1, 2021, Boone Health, Inc., a Missouri nonprofit corporation, will be added as a corporate member of the Hospital (the "Organizational Change"). For your convenience, pre- and post-closing organizational charts reflecting the Organizational Change are attached to this letter as Exhibit 1.

Currently, Christian Health Services Development Corporation, a Missouri nonprofit corporation, is the sole corporate member of the Hospital. The Organizational Change is the addition of Boone Health, Inc. as a second corporate member of the Hospital and will not result in any assets or operations being transferred from the Hospital. The Organizational Change will not have an impact on the Hospital's legal name, federal tax identification number, provider numbers, location, supervising personnel, operating procedures, or services.

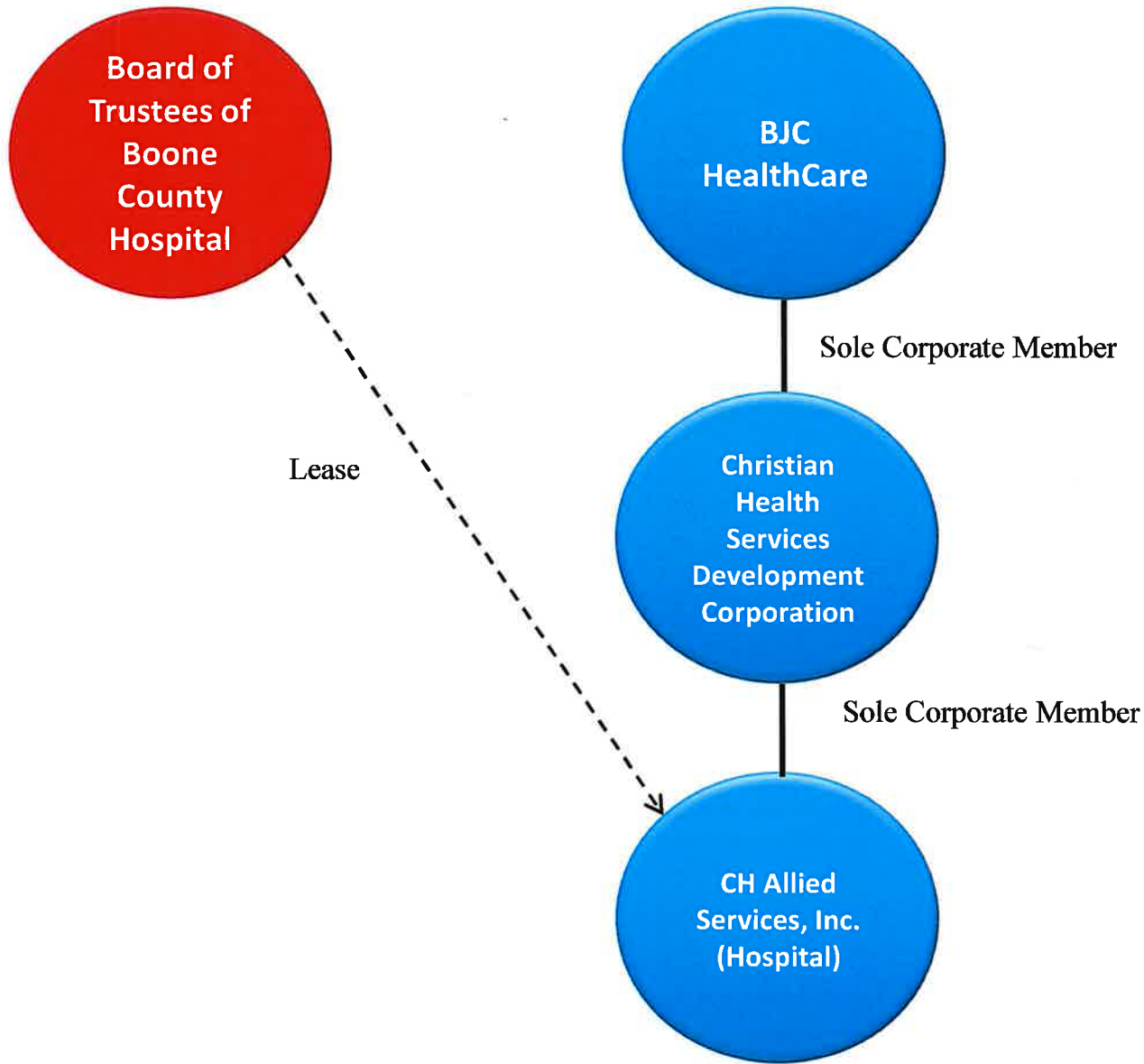

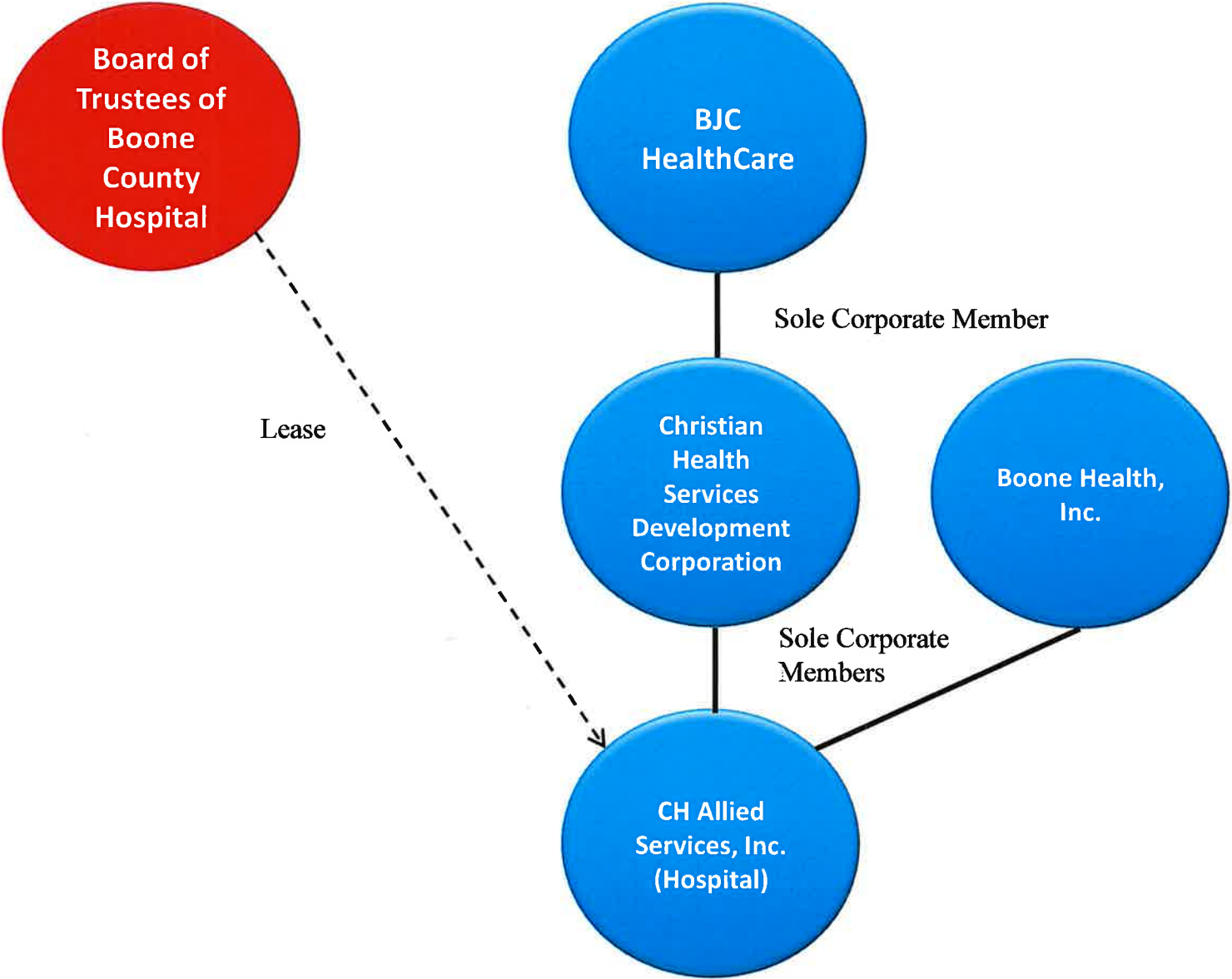
