## SUBJECT: AMENDMENT NO. 40 TO RADIOACTIVE MATERIALS LICENSE FOR MOBERLY HOSPITAL COMPANY, LLC, NRC LICENSE NO. 24-18695-01

Dear Mr. Harkness:

Enclosed is Amendment No. 40 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-18695-01 in accordance with your August 19, 2020 letter. As requested, and as discussed with your associate Ashley Barnes on December 29, 2020, we have added authorized user (AU) Samir Samuel Ashraf, D.O., limited to materials authorized under Title 10 of the *Code of Federal Regulations* (10 CFR) Sections 35.100, 35.200, and 35.300 (limited to sodium iodide I-131). We have also removed AUs Lancer Faler, M.D., and Allen Ernest Hillard, M.D. Finally, as discussed with Ms. Barnes, we have added an authorization for materials authorized under 10 CFR 31.11 for existing AU Mark Haskell Monroe, M.D. The additional authorization was needed as Ms. Barnes indicated that the 10 CFR 31.11 materials authorization in Item No. 6.D. to the license should be retained, and the only previous AU – Dr. Hillard – with a 10 CFR 31.11 authorization has been removed with this amendment. Your request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML20295A501.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III Office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under 10 CFR 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
