ORDER  
(Requesting Interim Report)

In response to the NRC Staff's Monthly Status Report 54,<sup>1</sup> the Board requests an interim written report following the January 7, 2021 meeting between the NRC Staff and Tribal Oglala Sioux Tribe Tribal Historic Preservation Officer to be submitted by January 15, 2021. The report should include a summary of the January 7 meeting and any additional follow-up actions. Rather than scheduling a further status conference in mid-January,<sup>2</sup> the Board requests that in the report the parties jointly indicate a time frame within the next 45 days (i.e., by the end of February 2021) within which it would be appropriate for the Board to hold a second status
