We are requesting the NRC's consent prior to a change in ownership.
 We are requesting a change in name only with no change in the managing control of the materials license.

On 12/31/2020 at 11:59 pm, all of Central Missouri Cardiology's assets will be purchased by Capital Region Medical Center.

Central Missouri Cardiology's new name will be Capital Region Physicians-Central Missouri Cardiology. All of the existing employees and physicians will be employed by Capital Region Medical Center and will continue to operate the Cardiology practice in the usual manner. There will no change in personnel or duties that relate to the licensed program.

There will be no change in the managing control of the material license. The Radiation Safety Officer, Dr. Patrick Morello, will retain managing control of the material license and thus possess the power to direct the activities under the license as explicitly delegated by the owner, Capital Region Medical Center.

The location will remain unchanged at 3501 A West Truman Blvd. Jefferson City, Missouri 65109. There will be no change in the location, facilities, equipment, radiation safety program, use, possession, waste management or other procedures that relate to the licensed program.



