Mr. Sharawy,

At the time of the telephone discussion in 2016, you were still within a year of the initial submission (August 2015) and our discontinuing the review of your application (November 2016). You would have to discuss the issue of payment of a new application fee again with someone from our Fees office. It is not usual for us to extend the grace period past 1 year.

Based on the fees listed on the NRC website (links below), last year the new application fee was \$3300.00. In addition, EACH YEAR that you possess the license, you will owe an annual fee of \$9300, based on last year's fees. These fees are adjusted every year and typically increase.

Based on our discussion with representatives from the State of New York, we understand that you have not again requested a license from the State of New York. As stated in the earlier email, we cannot issue a license to anyone for working at temporary job sites in NRC jurisdiction unless you have a valid license from a State for a location of storage and use for the portable gauges. If you wish to store the gauges in a location under NRC jurisdiction, we would first have to visit that location to verify that it is suitable for storage of gauges and that it is a valid location for operating your business.

Mr. Sharawy,

Because your application was in 2016 and more than a year's time has elapsed since review of the action was suspended, we cannot re-open that application action any more. If you want to apply for a license from the NRC, a new application submission, along with a new license application fee, will be required.

As stated in previous email and letter correspondence to you, the NRC will not issue a license to you unless you have a valid, licensed location to store your material. If that location is in an Agreement State such as New York, you would first need to obtain a license to possess, storage and use the licensed materials in that Agreement State.

If you choose to have a storage location in an NRC state, such as Connecticut or Delaware, that location can be named on the application to the NRC. We will need to visit that location prior to issuing a license, to determine if that location is suitable for possession and storage of the material, and that it is a valid place of business for your activities.

The links in the email below are still valid for obtaining the forms and guidance for a written application to the NRC. You may contact me if you have additional questions.

You would re-submit an application to the NRC through the same process as the original application you submitted in 2015. Attached is the letter dated April 19, 2016, detailing additional information that was needed, and the letter dated June 1, 2016, voiding that original application process because of your lack of response to the April 19, 2016 letter.

As NRC staff discussed with you during your original application process, you are located in the State of New York. The NRC does not have jurisdiction over possession and use of licensed materials in that State. An NRC license could only apply to your use of licensed material at temporary job sites in States under NRC jurisdiction. Such temporary job sites do not include authorization for storage of licensed material. As NRC staff discussed with your during your original application, the NRC will not issue a license to you, for use of licensed materials at temporary job sites in NRC States, without knowing that you are licensed to possess, use, and store the material under a valid license from an Agreement State (in this case, the State of New York). At the time your original license application was voided for lack of response, you did not have a license from the State of New York for such activities.

If you now have a license issued by the State of New York for the same purposes for which you are requesting an NRC license, you should submit a copy of that license with your application. You should re-

submit your application in full, including responses to the questions that were asked in the April 19, 2016 letter. You should use the following links:
