Mr. Sharawy,

We cannot accept storage in temporary site areas. You must have permanent storage location that is under a license. If that permanent storage location is in an Agreement State, then you must have an agreement state license for that location. If that permanent storage location is in an NRC state (Connecticut, Vermont, Delaware or Washington DC in the northeast), then you must have that license from the NRC.

The NRC cannot issue a license for use of the device at temporary job sites only, if you do not have a license for a permanent storage location. Any application for use of licensed materials at temporary job sites only should include a copy of a license for a permanent storage location.

Mr. Sharawy,

If you have an NRC license, and you want to work in an Agreement State such as New York or New Jersey, you would have to file a "reciprocity application" and pay a fee in order

to use licensed materials in the Agreement State. The application would be reviewed for approval before you could do the work.

It is similar for persons who have an Agreement State license who want to do work in an NRC state: they have to file a reciprocity application and pay the fee with the NRC and be approved to work under their Agreement State license in an NRC state. It also is similar for a person in an Agreement State such as New York, if they wanted to work in an Agreement States such as New Jersey. The New York licensee would have to file a reciprocity application and pay the fee with the State of New Jersey and obtain approval, prior to doing the work in New Jersey.

Mr. Sharawy,

The NRC has jurisdiction in Vermont, Connecticut, New Jersey, Delaware, and Washington DC in the northeast. These are the only states in the northeast in which the NRC can approve storage and use of licensed materials. In order to do such approval, we would have to know that you have an ongoing business at that location, with appropriate security and safety equipment for the storage and use of licensed material.

The NRC cannot approve a storage location in the State of New York.

You would re-submit an application to the NRC through the same process as the original application you submitted in 2015. Attached is the letter dated April 19, 2016, detailing additional information that was needed, and the letter dated June 1, 2016, voiding that original application process because of your lack of response to the April 19, 2016 letter.

As NRC staff discussed with you during your original application process, you are located in the State of New York. The NRC does not have jurisdiction over possession and use of licensed materials in that State. An NRC license could only apply to your use of licensed material at temporary job sites in States under NRC jurisdiction. Such temporary job sites do not include authorization for storage of licensed material. As NRC staff discussed with you during your original application, the NRC will not issue a license to you, for use of licensed materials at temporary job sites in NRC States, without knowing that you are licensed to possess, use, and store the material under a valid license from an Agreement State (in this case, the State of New York). At the time your original license application was voided for lack of response, you did not have a license from the State of New York for such activities.

If you now have a license issued by the State of New York for the same purposes for which you are requesting an NRC license, you should submit a copy of that license with your application. You should re-submit your application in full, including responses to the questions that were asked in the April 19, 2016 letter. You should use the following links:
