This is in reference to Peter Cordeau's letter dated October 26, 2020, requesting to amend NRC License Numbers 06-06941-01. In order to continue the review I will need the following additional information:

1. On Page 4, Item 3.d. of the 313A(AUS), I will need the name of the supervising individual, the license number that lists them as an authorized user, and a copy of that NRC or Agreement State license.
2. On Page 4, Item 3.e. of the 313A(AUS), provide the name and license number of the supervising individual. If this person is different from the individual named in Item 3.d., I will need a copy of their NRC or Agreement State license as well.

Once I receive the revised 313A(AUS) and the license(s), I will continue my review. Your reply must be a letter dated and signed by a member of hospital management. The letter may be scanned and submitted as a pdf document attached to an email (preferable); or it may be transmitted by facsimile

to (610) 337-5269; or it may be sent by regular mail. Please reply within 30 calendar days from the date of this email.
