Dear Ms. Myers:

Enclosed is Amendment No. 3 to your U.S. NRC Materials License No. 21-35537-01 in accordance with your request.

Based on the review of the information you provided, NRC staff have concluded that the gauging devices at the Ethocel facility are not leaking radioactive material and the former location of use is free of residual radioactive contamination. The Ethocel facility is acceptable for transfer to U.S. NRC Materials License No. 21-35600-01 (Nutrition & Biosciences USA 1, LLC).

You requested a correction to Condition 10.C. of your license to reflect the removal of an authorized use location for the Agilent Technologies Model G2397 Electron Capture Detector. A careful review of the referenced letter dated May 3, 2019, revealed that this location was identified in Attachment 1 of the request. Therefore, no correction to the license is needed. If you would like to request the removal of this location as an approved location of use, you may submit a separate request to amend the license to reflect the removal of the approved location of use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and
