This refers to your license amendment request dated December 15, 2020. Please find enclosed Amendment No. 38 adding and removing Authorized Users. Please note that the authorization language for Iodine-131 medical uses has been updated to reflect current regulation language in 10 CFR Part 35. In addition, please note that each authorized users' full name, including middle initial, has been listed in accordance with how the authorized user was listed on prior licenses.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
