# NOTICE OF HEARING (Enforcement Action)

This proceeding arises from an Enforcement Order (Order) issued against the Tennessee Valley Authority (TVA) on November 4, 2020, by the Nuclear Regulatory Commission, Office of Enforcement.<sup>1</sup> On November 30, 2020, TVA timely filed an answer and request for hearing<sup>2</sup> in response to the Order to TVA imposing a civil penalty. The NRC Staff agreed that TVA is entitled to a hearing.<sup>3</sup>

This Atomic Safety and Licensing Board was established on December 8, 2020.<sup>4</sup> An initial pre-hearing conference was held telephonically on December 17, 2020.<sup>5</sup> On January 14, 2021, this Board published an Initial Scheduling Order.<sup>6</sup>

In light of the foregoing, and consistent with 10 C.F.R. § 2.318(a),<sup>7</sup> please take notice that an evidentiary hearing will be conducted in this proceeding, beginning on August 23, 2021, at a place to be determined.<sup>8</sup> The hearing will be governed by the hearing procedures set forth in 10 C.F.R. Part 2, Subpart G,<sup>9</sup> which procedures supplement the general rules set forth in 10 C.F.R. Part 2, Subpart C.<sup>10</sup> During the course of the proceeding, the Board may, among other measures, hold oral arguments and pre-hearing conferences, and may reschedule the hearing or conduct additional evidentiary hearings.<sup>11</sup>

The public is invited to attend any oral argument, pre-hearing conference, or evidentiary hearing unless otherwise ordered by the Commission.<sup>12</sup> The time and place of any such sessions will be fixed by subsequent order(s); notices thereof will be published in the Federal
