Dear Mr. O'Rullian:

We have reviewed your letter and application dated November 19, 2020, in which you requested to expand the authorization currently listed in your NRC license. Before we can take further action, we will need the following additional information.

1. Receipt of decommissioning financial assurance in the amount of \$113,000 in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 30.35.

The NRC guidance on financial assurance NUREG-1757, Volume 3, Revision 1, can be found at https://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1757/v3/index.html. Please follow this guidance when submitting the financial instrument and standby trust agreement.

We request that you submit the financial assurance documents by February 12, 2021. We will assume that you do not wish to further pursue this licensing action if we do not receive a reply within the specified timeframe noted above.

Mr. O'Rullian:

The NRC has temporarily suspended the review of your request dated November 19, 2020 to amend NRC license 11-35111-01 to change the license authorization from "no possession is authorized" to establishing specific possession limits and the request to authorize a new location in which licensed material will be possessed, pending receipt of decommissioning financial assurance in the amount of \$113,000 in accordance with NRC regulation 10 CFR 30.35.

Attached is NRC guidance on financial assurance NUREG-1757, Volume 3, Revision 1. Please follow this guidance when submitting the \$113,000 financial instrument and standby trust agreement. Deviating from this guidance will result in delaying the review of the financial assurance documents. These financial documents need to be sent to the NRC in original form. Once these documents are received, reviewed and approved by the NRC, then the technical review of the license amendment request will continue.
