This is in reference to your letter dated September 2, 2020, regarding NRC License No. 37-35439-01. We reviewed the Decommissioning Funding Plan (DFP) dated August 20, 2020; Certification of Financial Assurance dated September 4, 2020; Irrevocable Standby Letter of Credit dated September 2, 2020; and revised Schedules A, B, and C of the Standby Trust Agreement dated August 20, 2020. In addition, we compared the DFP dated August 20, 2020, with the DFP dated October 17, 2017. To conduct our review, we used NUREG-1757, Vol. 3, Rev. 1, "Consolidated Decommissioning Guidance: Financial Assurance, Recordkeeping, and Timeliness", dated February 2012 (NUREG-1757, Vol. 3) (<https://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1757/v3/>).

In order to complete our review, we need the following information:

- (1) Please submit a revised Irrevocable Standby Letter of Credit reflecting the correct beneficiary address.

- (2) Please submit a revised Schedule C of the Standby Trust Agreement.

Please submit these documents by February 12, 2021. If this date cannot be met by the Financial Institution (CitiBank, N.A.), please promptly let me know, in writing, when the Financial Institution can provide the revisions.
