In accordance with Inspection Manual Chapter (IMC) 2561, "Decommissioning Power Reactor Inspection Program," the NRC Region III staff developed an inspection plan for the Enrico Fermi Atomic Power Plant, Unit 1, for calendar year 2021. The inspection plan is based on your current performance and your planned decommissioning activities for the site in January through December 2021.
