TVA and the individuals were notified of the enforcement actions this morning and the OE Director signed the letters. My branch chief, Dave Solorio, is reviewing the final packages before we send courtesy copies to TVA and the individuals.

John indicated last week that he didn't want to see the packages until they are complete. At this point they are signed by the OE Director but we are running final checks to make sure the packages have all the required enclosures, etc. John has a copy of the communications plan and OPA press release.

I defer to you about when to inform the states. John has a copy of the communications plan and OPA press release. The final package review should be complete later this afternoon. The letters/NOVs/Order are in ADAMS for public release tomorrow and OPA also plans to issue the press release tomorrow.
