This refers to your license amendment request dated December 3, 2020. Please find enclosed Amendment No. 22 adding Ajoy Kapoor, M.D., Robert F. Morrison, M.D., and Jonathan S. Siegfried, M.D. as authorized users. In addition, this amendment adds the location of use at 251 West Main Street, Branford, Connecticut, previously known as Connecticut Heart Group, P.C., and its license tie-down conditions authorized under its NRC license number 06-30080-01. The termination of the Connecticut Heart Group, P.C. license is being processed concurrently with this amendment under mail control number 624339. As discussed with Peter Armon on February 3, 2021, if you would like to add Dr. Kapoor as an Associate Radiation Safety Officer, please send in a subsequent amendment request along with his qualifications in accordance with 10 CFR 35.50.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
