Thanks for the queries. The TVA employee referenced in the paragraph was Geoff Cook, now retired. His cell phone is [REDACTED]

Ed Schrull's cell phone is [REDACTED]. By way of further explanation, Mr. Schrull was a direct report to Erin Henderson and is one several people Ms. Henderson accused of conspiring against her. While Mr. McBrearty was on suspension, Mr. Schrull contacted him (McBrearty) and said he had been called into Ms. Henderson's office and told to either resign/retire or be terminated. In response to this unilateral demand, Mr. Schrull eventually retired.

Michelle Conner (Harris) still works at TVA. Her non-work email is [REDACTED] and her cell is [REDACTED]

We do not have Alesia Cox Justice's contact information, but believe she still works at TVA and is friends with Michelle Conner, so Ms. Conner may have her contact information.

Also, just to correct the description below, the High Pressure Fire Protection event occurred at

Sequoyah (Mr. McBrearty's former plant) and not Watts Bar.

Mr. Kabat –

During Mr. MCBREARTY's interview he mentioned about an incident from March 2016, about an issue at Watts Bar dealing with the isolation of all the fire water being a reportability issue at Watts Bar dealing with 10 CFR 50.72. Initially everyone, to include MCBREARTY, thought it wasn't reportable to the NRC, then some new evidence was presented that showed a similar incident was reportable at another site. Based upon this new information, MCBREARTY and others agreed that it was reportable. SHEA, HENDERSON and others were involved in the discussions about this issue on the phone with MCBREARTY and others. After this discussions on the phone, MCBREARTY received a call from **another TVA employee (NFI)**, who stated that after the call, the group was asked why it took so long to get to that decision by the then TVA CNO (Joe GRIMES). MCBREARTY was told by **this TVA employee**, that HENDERSON then stated that she had been telling MCBREARTY for a week that it was reportable and drug MCBREARTY's "name through the mud." The **TVA employee** told MCBREARTY that he should not trust HENDERSON.
