I just called the attorney and explained that the CI requested OI to investigate back in Sept 2018. I also explained that normally once the CI was interviewed we don't shutdown investigations, provided the information in the manual and stated that it depends where we are in the process. I also explained that if they want to request us to shutdown the investigation, we will need that request in writing. At that point we will evaluate the request, but there are no guarantees that we will close the investigation since it is not the policy.

Counsel explained that TVA was interested in settling and that he will ask all the parties involved prior to making the official request. He also stated that we should continue the investigation. I reiterated that the consideration of closing a case is directly related to how far along we are in the process, that we will continue our process unless we hear from them. Counsel stated that he may settle privately and allow the OI investigation to continue.

John & Nicole, if the request is made to close the OI investigation and OI agrees to the request I will let you know.
