Dave,

I wanted to follow up on our phone call last week. We may have been talking past each other a bit. My concern is that TVA continues to provide additional information regarding your enforcement actions associated with my HIRD case outside of the NRC processes. My understanding of the NRC process is that choice letters were issued and TVA elected to provide additional information at PECs. I was invited to attend the PEC and make a statement. NRC then reviews the additional information provided at the PEC and issues the enforcement action.

I am concerned that TVA continues to weave their story with statements that would not have been made during the PECs with me being provided the opportunity to state the facts. Including direct communications with Commissioners and NRC executives?

When you stated "peoples' livelihoods" could be impacted by your decision, I want you to continue to take into consideration that my livelihood was destroyed by this company and these individuals through no fault of my own. I continue to hope that NRC will take actions to demonstrate there are consequences for TVA and its managers illegal actions.
