Hi Nasreen,

On the last page of the TVA cover letter Attachment 2 (ML20218A568), the first sentence needs to be changed.

- “subject” should be changed to “subjected”
- “a retaliatory investigation” should be replaced with “an investigation”
- the last word in the sentence should say “activity” instead of “activities”

The first sentence should now read:

Based on an investigation by the NRC OI, statements at PECs, exhibits, and supplemental information provided by the licensee and the individuals involved, the NRC determined that a former corporate employee (Individual B) was subjected to an investigation, then placed on paid administrative leave on October 15, 2018, and terminated on January 14, 2019, in part, for engaging in protected activity.
