SUBJECT: DRAFT LICENSE CONDITIONS TO ADDRESS ALTERNATE DECOMMISSIONING
SCHEDULE
AMENDMENT REQUEST AND REVISED FINANCIAL SURETY AMOUNT

Dear Mr. Nelson,

By letter dated December 9, 2019 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML19353A473) and as supplemented on January 28, 2020 (ADAMS Accession No. ML20035D684), Crow Butte Resources, Inc. (CBR), requested a license amendment for an alternate decommissioning (groundwater restoration) schedule for the Crow Butte Project.

A draft revision to License Condition (LC) 10.2.2 of Source Materials License SUA-1534 addressing this request is attached.

In addition, the NRC staff is revising LC 9.5 to include an updated surety amount (\$51,383,364). The updated surety amount reflects the 2020 surety amount previously verified by the NRC staff (ADAMS Accession No. ML20016A408) and adjusted by the 2021 surety estimate submitted by CBR (ADAMS Accession No. ML20290A466). By letter dated January 14, 2021 (ADAMS Accession No. ML21007A163), the NRC staff transmitted its verification of the updated surety estimate.

Please review the draft license conditions (LC 9.5 and LC 10.2.2) and provide your concurrence or comments within 7 days of receipt of this e-mail.
