Andy –

Here are the ARB documents related to the Prima Facie determination in the TVA case that is still open (2-2019-015).

As you can see there is no Prima Facie worksheet just the ARB documents [REDACTED]

In the ARB SUM document they described the Protected Activity as “Raised regulatory concerns and wrote CRs associated with regulatory concerns”

In the ARF (allegation receipt form) they described the PA as “Raising multiple regulatory compliance concerns to management, or not supporting management decisions related to questionable regulatory compliance decisions. Also speaking up to ECP and TVA OGC about fearing retaliation from her supervisor (E. Henderson - Corporate Licensing Manger).”

That last one about “fearing retaliation from her supervisor” is the one the evidence in the investigation seems to support and the DOL used to find merit in their case.
