SR. SPECIAL AGENT LUINA: All right. Today's date is May the 23rd, 2019. The time is now 9 a.m.

This interview is conduc -- being conducted with Edward Dustin Schrull, S-C-H-R-U-L-L, and I might have said Edwin, it's Edward, E-D-W-A-R-D, who is currently unemployed, but was formerly employed by the Tennessee Valley Authority, or the TVA, and we're going to talk about his time that he worked out there.

I just need to remind you, sir, this interview is being recorded. It will be transcribed at a later date. I need to ask you, sir, are you recording or transmitting this interview right now?

MR. SCHRULL: I am not.

SR. SPECIAL AGENT LUINA: Okay. The location of today's interview is at Mr. Schrull's residence located at 358 Magnolia Vale Drive in Chattanooga, Tennessee.

Also, as I explained to you, sir, all of our interviews are conducted under oath. Do you have any objections to providing information under oath today?

1 MR. SCHRULL: I do not.

2 SR. SPECIAL AGENT LUINA: All right. If
3 you could please raise your right hand with me. Mr.
4 Schrull, do you swear the testimony that you are about
5 to provide today will be the truth, the whole truth,
6 and nothing but the truth, so help you God?

7 MR. SCHRULL: Yes.

8 SR. SPECIAL AGENT LUINA: All right.
9 Thank you, sir. I appreciate you doing that.

10 Well, if you could, as I kind of
11 mentioned, kind of give me some background information
12 about yourself, sir, and just kind of explain what
13 your experience is in the nuclear industry --

14 MR. SCHRULL: Okay.

15 SR. SPECIAL AGENT LUINA: -- and the
16 (inaudible) you worked on and things like that, that
17 would be great.

18 MR. SCHRULL: I have over 44 years in the
19 nuclear industry. Got a masters in nuclear
20 engineering, University of Arizona, and I've worked
21 pretty much all over the country and Canada.

22 SR. SPECIAL AGENT LUINA: Okay.

23 MR. SCHRULL: Half of that time is in
24 technical areas, the other half has been in nuclear
25 licensing, although there's some flow in between

1 those, obviously.

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: Since 2013, I was working at
4 TVA. I retired in October of 2018.

5 SR. SPECIAL AGENT LUINA: October of 2018,
6 okay.

7 MR. SCHRULL: And at TVA, I was the
8 manager of Fleet Licensing, downtown Chattanooga.

9 Interfaced with, obviously, the -- the
10 three nuclear sites, their personnel, primarily with
11 their licensing organizations, but also with the rest,
12 the engineering operations, maintenance, et cetera.

13 SR. SPECIAL AGENT LUINA: Okay, excellent.
14 So, just -- but prior to TVA, what other licensees did
15 you work with?

16 MR. SCHRULL: Oh, licensees? Let's see,
17 when I first started I was -- I'll go through the
18 history.

19 SR. SPECIAL AGENT LUINA: Yes.

20 MR. SCHRULL: I was up at the FFTFS, Flux
21 Test Facility --

22 SR. SPECIAL AGENT LUINA: Yes.

23 MR. SCHRULL: -- up in the Tri-Cities.

24 SR. SPECIAL AGENT LUINA: Okay.

25 MR. SCHRULL: So, that was a DOE we were

1 contracting to, it was Westinghouse Hanford.

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: Then I worked for GE down in
4 San Jose. From there I went to Clinton. I worked at
5 the Clinton Station in Illinois.

6 SR. SPECIAL AGENT LUINA: Illinois, yes.

7 MR. SCHRULL: Then at Carolina Power and
8 Light in Raleigh, North Carolina. Also, Three Mile
9 Island. Down at Crystal River. Ontario Hydro nuclear
10 sites. Did I miss any?

11 SR. SPECIAL AGENT LUINA: Did you do,
12 like, outage work or were you kind of just --

13 MR. SCHRULL: No. I went to problem
14 plants --

15 SR. SPECIAL AGENT LUINA: Okay.

16 MR. SCHRULL: -- in licensing and -- and
17 project management.

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: So, Crystal River, it was
20 when they were voluntarily shut down and I --

21 SR. SPECIAL AGENT LUINA: Okay.

22 MR. SCHRULL: -- worked for -- in the
23 recovery efforts for that.

24 SR. SPECIAL AGENT LUINA: Okay.

25 MR. SCHRULL: Three Mile Island,

1 obviously, well, it was after the accident.

2 SR. SPECIAL AGENT LUINA: Yes, after the
3 accident.

4 MR. SCHRULL: '88 to '94.

5 SR. SPECIAL AGENT LUINA: Okay.

6 MR. SCHRULL: We were putting in the post
7 refueling monitored storage, PDMS --

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: -- safety analysis report
10 licensing to get that into its storage --

11 SR. SPECIAL AGENT LUINA: Okay.

12 MR. SCHRULL: -- condition. Carolina
13 Power and Light, I was in corrective action. I was a
14 director of (inaudible). And Ontario Hydro, we put in
15 a corrective action program --

16 SR. SPECIAL AGENT LUINA: Program.

17 MR. SCHRULL: -- for the entire
18 12,000 --

19 SR. SPECIAL AGENT LUINA: Okay.

20 MR. SCHRULL: -- people that were working
21 there.

22 SR. SPECIAL AGENT LUINA: Okay.

23 MR. SCHRULL: Clinton it was pre-
24 operational. It was in the licensing organization.

25 SR. SPECIAL AGENT LUINA: There's a lot --

1 would you say the majority of your time has been in
2 licensing, I guess?

3 MR. SCHRULL: I would say half of it.

4 SR. SPECIAL AGENT LUINA: Half of it.

5 MR. SCHRULL: You know, when I look at
6 putting together a number of years and months and
7 everything, it looks about half and half.

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: However, when I was in the
10 technical aspects, you know, you obviously deal with
11 the FSARS, tech specs, and things like that.

12 SR. SPECIAL AGENT LUINA: Okay.

13 MR. SCHRULL: So, the lines are somewhat
14 blurry, but licensing has been at least half of what
15 my career has been --

16 SR. SPECIAL AGENT LUINA: Okay.

17 MR. SCHRULL: -- involved in.

18 SR. SPECIAL AGENT LUINA: So, who did you
19 report to when you were at TVA? Who was your direct
20 supervisor?

21 MR. SCHRULL: When I retired it was Erin
22 Henderson.

23 SR. SPECIAL AGENT LUINA: And that's E-R-
24 I-N, right? Henderson?

25 MR. SCHRULL: Yes. H-E-N-D-E-R-S-O-N.

1 And before Erin it was Mike McBrearty --

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: -- for, I'd say a short
4 time. I think it was, like, a year, year and a half,
5 something like that.

6 SR. SPECIAL AGENT LUINA: Yes, he did a
7 temporary stint up there.

8 MR. SCHRULL: Well it was -- he was a --
9 the general manager so, I don't know if you'd consider
10 that temporary. It was just he got into the position.
11 A year and a half later he basically swapped positions
12 with Erin.

13 SR. SPECIAL AGENT LUINA: Yes.

14 MR. SCHRULL: And then before that, it was
15 Joe Shea. So, the -- the position of general manager
16 came in between Joe and I.

17 SR. SPECIAL AGENT LUINA: Okay. All
18 right. And did you have people reporting to you?

19 MR. SCHRULL: I did.

20 SR. SPECIAL AGENT LUINA: Who were your --
21 who were your direct reports?

22 MR. SCHRULL: Russ Wells, Gordon Williams,
23 I'll go slow.

24 SR. SPECIAL AGENT LUINA: Okay.

25 MR. SCHRULL: Tom Hess, H-E-S-S, and then

1 a few contractors.

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: There were other people
4 early, yes, Clyde Mackerman (phonetic).

5 SR. SPECIAL AGENT LUINA: That's fine.

6 MR. SCHRULL: Okay.

7 SR. SPECIAL AGENT LUINA: Before that
8 those other ones sound familiar, okay. Prior to your
9 time out at -- in TVA, did you know Mr. McBrearty from
10 --

11 MR. SCHRULL: No.

12 SR. SPECIAL AGENT LUINA: Okay. Do you
13 know Joe Shea prior to working --

14 MR. SCHRULL: No.

15 SR. SPECIAL AGENT LUINA: -- at TVA or
16 -- or Erin Henderson at all?

17 MR. SCHRULL: No.

18 SR. SPECIAL AGENT LUINA: Okay. I always
19 ask that because you know, as you know, it's a small
20 community --

21 MR. SCHRULL: It is.

22 SR. SPECIAL AGENT LUINA: -- and people
23 are, like, oh yes, I've known Joe for 20 years and
24 stuff. So, it's always interesting to find out that.

25 All right, Mr. Schrull. Well, if you

1 could -- your -- your contact with Mr. McBrearty
2 during that time, would you say it was -- your work-
3 related contact, obviously, was it daily, weekly,
4 monthly, or.

5 MR. SCHRULL: When he was my general
6 manager --

7 SR. SPECIAL AGENT LUINA: Yes.

8 MR. SCHRULL: -- it was obviously daily.

9 SR. SPECIAL AGENT LUINA: Yes.

10 MR. SCHRULL: And then when he became the
11 licensing manager at Sequoyah, let's say weekly, at
12 least.

13 SR. SPECIAL AGENT LUINA: Okay.

14 MR. SCHRULL: And sometimes more often,
15 but that's a good --

16 SR. SPECIAL AGENT LUINA: Weekly --

17 MR. SCHRULL: Yes.

18 SR. SPECIAL AGENT LUINA: -- on average.

19 MR. SCHRULL: Yes.

20 SR. SPECIAL AGENT LUINA: Okay. And then
21 with -- with Erin when she was your supervisor, or.

22 MR. SCHRULL: Obviously, daily, yes.

23 SR. SPECIAL AGENT LUINA: Okay. Daily
24 contact with her. All right.

25 MR. SCHRULL: Whenever she wasn't

1 traveling or I wasn't traveling, you know, we had a
2 number of meetings --

3 SR. SPECIAL AGENT LUINA: Okay.

4 MR. SCHRULL: -- off-site.

5 SR. SPECIAL AGENT LUINA: So, you had to
6 keep knowledge and understanding of, I guess, of all
7 three sites you'd say. You didn't focus --

8 MR. SCHRULL: Yes.

9 SR. SPECIAL AGENT LUINA: -- just on one.
10 Okay.

11 MR. SCHRULL: Now, my group -- so, just to
12 be clear, when you talk about nuclear licensing, there
13 are two sides to it, really.

14 SR. SPECIAL AGENT LUINA: Okay.

15 MR. SCHRULL: There's a compliance
16 licensing side, which is typically the people that are
17 out at the site, licensing organizations, and they
18 deal with resident inspectors, and -- so, they're on
19 the day to day evaluation --

20 SR. SPECIAL AGENT LUINA: Answering
21 questions.

22 MR. SCHRULL: -- of what's going on.

23 SR. SPECIAL AGENT LUINA: Okay.

24 MR. SCHRULL: The other one, I call meat
25 licensing. Kind of a funny term, but it's dealing

1 with headquarters of NRC --

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: -- and so, that's tech spec
4 oriented where we are submitting license and memo
5 requests, responding to REIs, et cetera.

6 SR. SPECIAL AGENT LUINA: Okay.

7 MR. SCHRULL: So, that was the function
8 that my group filled for all three sites. We were
9 responsible for submitting the license and memo
10 requests and dealing with the NRC headquarters.

11 SR. SPECIAL AGENT LUINA: Okay.

12 MR. SCHRULL: We did very little with the
13 resident inspector.

14 SR. SPECIAL AGENT LUINA: With the
15 residents -- what about the region, the same thing?

16 MR. SCHRULL: Very little.

17 SR. SPECIAL AGENT LUINA: Very little.

18 MR. SCHRULL: In fact, I -- in the last
19 six years, I have not been down to Atlanta at all.

20 SR. SPECIAL AGENT LUINA: Okay. Is that
21 something site licensing would --

22 MR. SCHRULL: Site licensing, but also if
23 you look at what corporate licensing did, corporate
24 nuclear affairs, regulatory affairs, we had another
25 group within -- under Erin that dealt with that --

1 more site --

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: -- compliance type stuff.

4 SR. SPECIAL AGENT LUINA: Okay.

5 MR. SCHRULL: And inspections.

6 SR. SPECIAL AGENT LUINA: Okay. Based on
7 your time out there working with -- with and around
8 Mr. McBrearty, how would you describe, just in general
9 terms, his -- his -- not work -- his proficiency in
10 his job and his work performance I guess.

11 MR. SCHRULL: I -- I believe Mike is a
12 -- I know Mike is an intelligent experienced
13 individual. I wouldn't -- I wouldn't say -- there's
14 nothing bad that I would say about Mike. He's got a
15 good work ethic, fair-minded, logical --

16 SR. SPECIAL AGENT LUINA: Meaning he can
17 -- he can perform his job duties and he's -- he's not
18 -- not, like, how did this guy get this job kind of
19 thing --

20 MR. SCHRULL: Correct.

21 SR. SPECIAL AGENT LUINA: -- it's, but
22 he's more -- he could do his work.

23 MR. SCHRULL: Right. He can do -- he can
24 do his job. I do know of his previous experience out
25 at (inaudible).

1 SR. SPECIAL AGENT LUINA: The same with
2 Ms. Henderson. How would you describe her job
3 performance? I know she was your supervisor --

4 MR. SCHRULL: Yes.

5 SR. SPECIAL AGENT LUINA: -- but I mean,
6 how was --

7 MR. SCHRULL: She, once again, an
8 intelligent young lady. Good at what she does.

9 SR. SPECIAL AGENT LUINA: Yes.

10 MR. SCHRULL: She doesn't have -- she
11 didn't have a lot of experience coming into the job
12 but she's a fast learner and did a -- did a good job.

13 SR. SPECIAL AGENT LUINA: Okay.

14 MR. SCHRULL: More management oriented
15 than technically proficient. But obviously, you've
16 got to take some time to -- to get into that.

17 SR. SPECIAL AGENT LUINA: Okay. Did
18 anything about Mike's workplace behavior, anything
19 that was unprofessional or insubordinate about the way
20 he carried himself or the way he acted that you
21 witnessed or observed, that you were, like, whoa, man.

22 MR. SCHRULL: No, no.

23 SR. SPECIAL AGENT LUINA: Okay. Okay.

24 MR. SCHRULL: Never.

25 SR. SPECIAL AGENT LUINA: Okay.

1 MR. SCHRULL: But we -- now, realizing
2 that my group was separated from the day to day --

3 SR. SPECIAL AGENT LUINA: Yes.

4 MR. SCHRULL: -- issues at the site, and
5 I didn't get involved in a lot of those type of
6 issues, but we always had meetings, group meetings, at
7 least once a month, if not more often.

8 SR. SPECIAL AGENT LUINA: That's true.
9 Were you involved in the peer team phone calls?

10 MR. SCHRULL: I guess sometimes.

11 SR. SPECIAL AGENT LUINA: Sometimes. What
12 about the peer team face to face? Those were once a
13 month?

14 MR. SCHRULL: Also sometimes.

15 SR. SPECIAL AGENT LUINA: Sometimes, okay.

16 MR. SCHRULL: They focus more on
17 compliance issues. I was -- I attended those when
18 there were more LAR --

19 SR. SPECIAL AGENT LUINA: Okay.

20 MR. SCHRULL: -- issues that we needed to
21 resolve.

22 SR. SPECIAL AGENT LUINA: Okay. And we'll
23 talk about that. The --

24 MR. SCHRULL: But -- but to answer, I'm
25 sorry. To answer your question, though, I've never

1 witnessed any "insubordination" or anything from Mike.

2 SR. SPECIAL AGENT LUINA: Or being
3 unprofessional at all that --

4 MR. SCHRULL: No.

5 SR. SPECIAL AGENT LUINA: No? Okay. And
6 the interactions you had with him. Same question
7 about Erin. Anything you recognize with her that you
8 thought was unprofessional or --

9 MR. SCHRULL: No.

10 SR. SPECIAL AGENT LUINA: -- inappropriate
11 in the workplace, or.

12 MR. SCHRULL: Nothing like that.

13 SR. SPECIAL AGENT LUINA: Okay. All
14 right. Let's see. You -- you mentioned about the
15 LARs.

16 MR. SCHRULL: Yes.

17 SR. SPECIAL AGENT LUINA: How much
18 interaction and involvement were you in the NCVs, the
19 non-cited violations that Sequoyah had dealing with
20 the Kirk Key, K-I-R-K Key --

21 MR. SCHRULL: Yes.

22 SR. SPECIAL AGENT LUINA: -- and the --
23 the service life issue. They were out at --

24 MR. SCHRULL: Service life issue, none.

25 SR. SPECIAL AGENT LUINA: None.

1 MR. SCHRULL: I had no interaction. Kirk
2 Key we did because we put in a -- an LAR --

3 SR. SPECIAL AGENT LUINA: Okay.

4 MR. SCHRULL: -- for that. More on the
5 periphery of what was going on --

6 SR. SPECIAL AGENT LUINA: Yes.

7 MR. SCHRULL: -- with the Kirk Key, so I
8 understand the -- how -- the direction that it went in
9 the sense that we -- it was a -- a device that should
10 have been form fit function and didn't fit basically.
11 So, we did put in an LAR to resolve that issue.

12 SR. SPECIAL AGENT LUINA: Okay. And were
13 you aware if Mr. McBrearty had any concerns with the
14 way those NCVs were being addressed, you know, through
15 corporate nuclear licensing?

16 MR. SCHRULL: No. I'm not aware of
17 any --

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: -- any issues that he had.

20 SR. SPECIAL AGENT LUINA: He never
21 discussed that with you, or.

22 MR. SCHRULL: Not with regard to the NCVs.

23 SR. SPECIAL AGENT LUINA: Okay.

24 MR. SCHRULL: You know, we -- we obviously
25 talked about the license memo request that was going

1 to resolve the issue.

2 SR. SPECIAL AGENT LUINA: Okay. I guess
3 anything with -- with the delay because I mean, the
4 NCVs were issued in 2015. It wasn't until much --
5 like two -- two years later, I think the LAR was
6 finally (inaudible). Did he talk to you about that?
7 Or do you have any insight into that issue and why
8 there was a delay, or?

9 MR. SCHRULL: I -- I don't.

10 SR. SPECIAL AGENT LUINA: Okay.

11 MR. SCHRULL: I know that things take time
12 to -- to resolve. I -- I don't know why it did take
13 that amount of time to resolve that issue. I also
14 understand that there was a disagreement with the NCV
15 itself --

16 SR. SPECIAL AGENT LUINA: Okay.

17 MR. SCHRULL: -- between TVA and NRC.

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: But once again, I'm not --
20 I'm not -- I wasn't privy to any extensive
21 conversation about that.

22 SR. SPECIAL AGENT LUINA: Meaning their
23 discussions --

24 MR. SCHRULL: Yes.

25 SR. SPECIAL AGENT LUINA: -- internally,

1 or with --

2 MR. SCHRULL: It wouldn't -- it wouldn't
3 have involved me --

4 SR. SPECIAL AGENT LUINA: Okay.

5 MR. SCHRULL: -- sorry. I'll just put
6 this on mute. It would have involved other people in
7 the -- in our organization like -- more like a Jim
8 Polickoski group.

9 SR. SPECIAL AGENT LUINA: Okay.

10 MR. SCHRULL: I don't know if that name is
11 --

12 SR. SPECIAL AGENT LUINA: Oh, yes. It's
13 come up.

14 MR. SCHRULL: Okay, good.

15 SR. SPECIAL AGENT LUINA: That's -- that's
16 one that I've had trouble spelling but --

17 MR. SCHRULL: I can spell it if you'd
18 like.

19 SR. SPECIAL AGENT LUINA: You know how to
20 spell it? Go ahead, yes, if you don't mind.

21 MR. SCHRULL: P-O-L-I-C-K-O-S-K-I.

22 SR. SPECIAL AGENT LUINA: All right.
23 Thank you.

24 Okay. So -- so, do you recall -- I think
25 I might have asked you this already, but I'll ask you

1 more specifically, if Mr. McBrearty brought up during
2 peer team phone calls or during peer team discussions
3 or any -- or any time that you were witnessed to --
4 that Mr. McBrearty brought up specifically about the
5 way corporate nuclear licensing and the decision-
6 making process that was involved and the approach that
7 was taken to address the NCVs, you know, why they
8 weren't just denied in 2015 instead of kicking the can
9 down the road all the time until, you know, the LAR
10 was -- was written and --

11 MR. SCHRULL: I do -- I am aware of that.

12 SR. SPECIAL AGENT LUINA: Okay.

13 MR. SCHRULL: That there was some
14 discussion about we should have denied the violation
15 immediately and I do know that that was a discussion
16 that was held between Joe, Erin, Mike, people at -- at
17 Sequoyah.

18 SR. SPECIAL AGENT LUINA: Sequoyah.

19 MR. SCHRULL: I am aware of that and I'm
20 aware that they -- there was a meeting of the minds
21 that they weren't going to deny it at that time. You
22 know, that -- that seemed to -- it seemed to be
23 brought up every so often.

24 SR. SPECIAL AGENT LUINA: Yes.

25 MR. SCHRULL: But not -- I wasn't aware of

1 what the -- if there was any disagreements that
2 -- that, you know, fist --

3 SR. SPECIAL AGENT LUINA: Yes.

4 MR. SCHRULL: -- pounding on the table
5 that here's what we ought to do.

6 SR. SPECIAL AGENT LUINA: Okay. Okay. I
7 guess I -- it seemed -- okay, I see. All right. All
8 right. And you were aware of that because of --

9 MR. SCHRULL: Oh, just --

10 SR. SPECIAL AGENT LUINA: -- of Mike
11 talking about it?

12 MR. SCHRULL: -- just chattering.

13 SR. SPECIAL AGENT LUINA: Just chattering,
14 okay.

15 MR. SCHRULL: I couldn't tell -- you know,
16 Mike and I didn't sit down because that wasn't my
17 role.

18 SR. SPECIAL AGENT LUINA: Yes.

19 MR. SCHRULL: We didn't sit down and say,
20 you know, we're -- we're not doing this correctly. We
21 need to do this instead.

22 SR. SPECIAL AGENT LUINA: Okay.

23 MR. SCHRULL: That was not part of what --
24 what I was aware of.

25 SR. SPECIAL AGENT LUINA: Okay. Okay.

1 And so you -- yes, you were not the direct supervisor
2 of Mike when he was out at Sequoyah.

3 MR. SCHRULL: Oh, oh, no.

4 SR. SPECIAL AGENT LUINA: No.

5 MR. SCHRULL: Yes, I would say that I
6 probably went to maybe a quarter of the peer team
7 meetings.

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: It just -- once again, they
10 were more compliance than -- than into what I was
11 doing.

12 SR. SPECIAL AGENT LUINA: Were you working
13 October of '18?

14 MR. SCHRULL: Yes.

15 SR. SPECIAL AGENT LUINA: Do you remember,
16 maybe, during a -- a peer team phone call, a comment
17 -- again, Mr. McBrearty was maybe bringing up issues
18 again with the decision making process --

19 MR. SCHRULL: Yes.

20 SR. SPECIAL AGENT LUINA: -- and this
21 might have been in early 2018, okay --

22 MR. SCHRULL: All right.

23 SR. SPECIAL AGENT LUINA: -- when this
24 occurred. Maybe May of 2018 to be specific. That
25 during the phone call, that you may or may not have

1 been on, I'm not sure if you were on the phone
2 call --

3 MR. SCHRULL: All right.

4 SR. SPECIAL AGENT LUINA: -- or not, that
5 McBrearty brought up again about, you know, he had
6 actually put in some condition reports I think by this
7 point --

8 MR. SCHRULL: Okay.

9 SR. SPECIAL AGENT LUINA: -- dealing with
10 the decision making process and some had been
11 -- had been closed by Ms. Henderson and maybe they
12 were going to open up another one as well, but during
13 this phone call, some statements were made after
14 McBrearty brought this up, particularly by Mr. Shea,
15 saying, you know, asking Mr. McBrearty, are you saying
16 that there's a problem with David Zuffin's (phonetic)
17 -- you know David Zuffin --

18 MR. SCHRULL: Yes.

19 SR. SPECIAL AGENT LUINA: -- Zuffin and
20 his organization? Do you remember a comment like that
21 being made by Mr. Shea to Mr. McBrearty?

22 MR. SCHRULL: Not at all.

23 SR. SPECIAL AGENT LUINA: Not at all,
24 okay. Then again, you might -- you may or may not
25 have been --

1 MR. SCHRULL: Yes.

2 SR. SPECIAL AGENT LUINA: -- on the phone
3 call --

4 MR. SCHRULL: Yes.

5 SR. SPECIAL AGENT LUINA: -- so, yes. I
6 was just asking.

7 MR. SCHRULL: You know, that -- that
8 doesn't ring a bell at all.

9 SR. SPECIAL AGENT LUINA: Okay.

10 MR. SCHRULL: So, this was Joe asking Mike
11 that he believes there's an issue with Dave's
12 organization?

13 SR. SPECIAL AGENT LUINA: He's asking
14 Mike, yes, do you think there's a problem -- are you
15 saying there's a problem with David Zuffin's
16 organization, you know.

17 MR. SCHRULL: No, I don't remember that.

18 SR. SPECIAL AGENT LUINA: Okay. All
19 right. All right. So, did you -- you ended up
20 retiring from TVA; is that correct?

21 MR. SCHRULL: I did.

22 SR. SPECIAL AGENT LUINA: All right. Were
23 you given possibly some type of ultimatum to either
24 resign or retire or be terminated?

25 MR. SCHRULL: Not be terminated --

1 SR. SPECIAL AGENT LUINA: Okay.

2 MR. SCHRULL: -- but it was an agree --
3 agreed upon retirement.

4 SR. SPECIAL AGENT LUINA: Okay.

5 MR. SCHRULL: Voluntary separation.

6 SR. SPECIAL AGENT LUINA: Voluntary
7 separation, okay.

8 Is there -- is there anything you wanted
9 to shed some light on that? Was there any reason that
10 you were -- you were told that? Were you, I don't
11 know, offered some type of evidence, like, hey, you
12 need to leave because we got this on you kind of
13 thing.

14 MR. SCHRULL: No.

15 SR. SPECIAL AGENT LUINA: Okay.

16 MR. SCHRULL: The -- I believe it was more
17 of a regime change --

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: -- because not only did I
20 take the voluntary, but I understand Beth Wetzel is no
21 longer with TVA.

22 SR. SPECIAL AGENT LUINA: Yes.

23 MR. SCHRULL: So, that's kind of the old
24 hand, as it were, and they wanted to go in a different
25 direction.

1 SR. SPECIAL AGENT LUINA: Did anybody ever
2 accuse you or -- or tell you that, you know, you --
3 you were creating a harassing and intimidating
4 environment or -- or -- for Ms. Henderson at all?

5 MR. SCHRULL: Not me. No.

6 SR. SPECIAL AGENT LUINA: Okay. Are you
7 aware of that issue or that allegation being raised?

8 MR. SCHRULL: I've heard of that but I
9 don't have firsthand knowledge of that.

10 SR. SPECIAL AGENT LUINA: Okay. Okay.
11 That -- that you were creating or that other people
12 were.

13 MR. SCHRULL: That other people were.

14 SR. SPECIAL AGENT LUINA: Okay.

15 MR. SCHRULL: Or alleged to -- to be.

16 SR. SPECIAL AGENT LUINA: Yes. So, you
17 felt -- explain to me again what happened with the
18 resign or retire conversation and who that was with.

19 MR. SCHRULL: That was with Erin and a HR
20 rep.

21 SR. SPECIAL AGENT LUINA: Okay.

22 MR. SCHRULL: And basically it was giving
23 me the opportunity to voluntarily resign after
24 September 30th, so that I wouldn't take any financial
25 hit on that, and that's what I did.

1 SR. SPECIAL AGENT LUINA: Okay. But you
2 felt it was more that they just wanted to --

3 MR. SCHRULL: Go -- go in a different
4 direction. Apparently, I wasn't doing what they felt
5 I should as a manager. So, they wanted to go in a
6 different direction.

7 SR. SPECIAL AGENT LUINA: And how do you
8 feel about that? I mean, you've got 40-plus years
9 experience in this industry and all -- all the country
10 working and --

11 MR. SCHRULL: I was planning on retiring
12 by the end of the year.

13 SR. SPECIAL AGENT LUINA: Okay.

14 MR. SCHRULL: End of December into
15 January. Right around that time.

16 SR. SPECIAL AGENT LUINA: And they
17 probably knew that I guess?

18 MR. SCHRULL: Oh, absolutely. I --

19 SR. SPECIAL AGENT LUINA: Okay. All
20 right.

21 MR. SCHRULL: -- I discussed that a number
22 of times. So, rather -- I guess, rather than allowing
23 the flight path, they just -- this is a -- this is a
24 -- it was a good financial move for me --

25 SR. SPECIAL AGENT LUINA: For you, okay.

1 MR. SCHRULL: -- and so, that's --

2 SR. SPECIAL AGENT LUINA: You don't feel
3 it was a negative thing to you or --

4 MR. SCHRULL: No.

5 SR. SPECIAL AGENT LUINA: -- that it
6 didn't hurt you at all or something?

7 MR. SCHRULL: No.

8 SR. SPECIAL AGENT LUINA: Okay. That you
9 were being pushed out because -- I mean, when you --
10 and I'm not trying to put words in your mouth, I'm
11 just trying to --

12 MR. SCHRULL: Sure.

13 SR. SPECIAL AGENT LUINA: -- I'm trying to
14 deduce because other people have -- have assumed
15 there's reasons why you left, I guess, without talking
16 with you, and they're making it sound to me that,
17 well, no, you had safety issues and concerns and you
18 were just pushed out the door.

19 MR. SCHRULL: I had no safety issues or
20 concerns.

21 SR. SPECIAL AGENT LUINA: Okay.

22 MR. SCHRULL: I believe that our -- our
23 group was performing well, we were doing everything we
24 needed to do. It just seemed like we weren't either
25 doing it fast enough or --

1 SR. SPECIAL AGENT LUINA: Okay.

2 MR. SCHRULL: -- but again, I never had a
3 safety concern. If I had safety concerns, I would
4 have brought them up.

5 SR. SPECIAL AGENT LUINA: Okay. You
6 didn't feel -- the environment wasn't such that you
7 were, you know, using the word "chilled" that you
8 didn't feel like you could -- in fear of retaliation?

9 MR. SCHRULL: Oh, absolutely not.

10 SR. SPECIAL AGENT LUINA: You felt like
11 you could raise safety concerns?

12 MR. SCHRULL: Yes, no.

13 SR. SPECIAL AGENT LUINA: Okay. Okay.
14 So, you were not threatened with termination. You
15 -- you were told to either -- right?

16 MR. SCHRULL: Well, I was given the
17 opportunity to voluntarily retire. So --

18 SR. SPECIAL AGENT LUINA: Or -- or we'll
19 terminate you?

20 MR. SCHRULL: Well, no. Not necessarily.

21 SR. SPECIAL AGENT LUINA: Not necessarily,
22 okay. So, it's here's, like, a separation agreement
23 kind of thing --

24 MR. SCHRULL: Right.

25 SR. SPECIAL AGENT LUINA: -- would you

1 like to take this.

2 MR. SCHRULL: Right.

3 SR. SPECIAL AGENT LUINA: If not, we might
4 (inaudible).

5 MR. SCHRULL: Right. Kind of like the
6 copper parachute.

7 SR. SPECIAL AGENT LUINA: Okay. The
8 copper parachute? Okay. Not the golden parachute?

9 MR. SCHRULL: No.

10 SR. SPECIAL AGENT LUINA: The diamond
11 parachute?

12 MR. SCHRULL: Yes.

13 SR. SPECIAL AGENT LUINA: But they said
14 the reasons were we just want to do a change and we
15 want to do it now, rather than wait for you to leave
16 later on. Is that --

17 MR. SCHRULL: Yes.

18 SR. SPECIAL AGENT LUINA: -- pretty
19 much --

20 MR. SCHRULL: Yes.

21 SR. SPECIAL AGENT LUINA: -- essentially
22 what they're saying? Okay. And it wasn't because we
23 have --

24 MR. SCHRULL: Well, the -- you know, once
25 again, performance issues were what they were citing.

1 SR. SPECIAL AGENT LUINA: Okay. Did you
2 say that? I'm sorry. I might have missed that. So,
3 they were citing some performance issues --

4 MR. SCHRULL: Yes.

5 SR. SPECIAL AGENT LUINA: -- on your part.

6 MR. SCHRULL: That our -- that our group
7 wasn't performing --

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: -- to what their
10 expectations were.

11 SR. SPECIAL AGENT LUINA: All right. And
12 how did -- is that --

13 MR. SCHRULL: I -- I didn't agree with
14 that --

15 SR. SPECIAL AGENT LUINA: Okay.

16 MR. SCHRULL: But, you know, this -- once
17 again, the -- the copper parachute allowed me to do
18 what I was going to do anyway.

19 SR. SPECIAL AGENT LUINA: Okay.

20 MR. SCHRULL: A few months earlier to work
21 on my wedge play.

22 SR. SPECIAL AGENT LUINA: Okay. Your
23 wedge play. All right. All right. You mentioned Ms.
24 Wetzels.

25 MR. SCHRULL: Yes.

1 SR. SPECIAL AGENT LUINA: What was your
2 interaction with her? Because she worked up at
3 corporate.

4 MR. SCHRULL: She did. She was -- there
5 were three groups; mine was one, Jim's was another on
6 more of the compliance inspections aspect, and her
7 group was more looking at issues long-term, oh, I
8 forget the -- the name that they used for her group
9 but it was, like, almost operating
10 experience --

11 SR. SPECIAL AGENT LUINA: Yes.

12 MR. SCHRULL: -- things that would occur
13 in the -- in the future and try to position TVA to be
14 prepared to -- to handle those issues.

15 SR. SPECIAL AGENT LUINA: She was in a
16 different group.

17 MR. SCHRULL: Yes --

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: -- but she worked ten feet
20 away from me.

21 SR. SPECIAL AGENT LUINA: Okay.

22 MR. SCHRULL: We were all pretty -- you
23 know, it was a small group, 20-something people.

24 SR. SPECIAL AGENT LUINA: Do you remember
25 an issue out at Watts Bar. I'll narrow it down,

1 sorry. Dealing with the -- maybe in July or so of
2 2017, dealing with how TVA would perform TS, technical
3 specification surveillances, that had approved NRC
4 extensions, however, Watts Bar did not do the TS
5 surveillances when they -- when they could have done
6 the TS surveillances and this was questioned by -- is
7 this making sense to you at
8 all --

9 MR. SCHRULL: Yes.

10 SR. SPECIAL AGENT LUINA: -- what I'm
11 saying? Okay, and --

12 MR. SCHRULL: Yes.

13 SR. SPECIAL AGENT LUINA: -- and Ms.
14 Wetzel might have brought this up during team meetings
15 or --

16 MR. SCHRULL: Could have.

17 SR. SPECIAL AGENT LUINA: Okay.

18 MR. SCHRULL: I'm not sure that she
19 brought it up specifically but I knew that there was
20 discussion about that, that why didn't they perform
21 those surveillances at the right time, instead of us
22 having to -- because we have to go in and ask for
23 extensions.

24 SR. SPECIAL AGENT LUINA: Yes.

25 MR. SCHRULL: So, that was -- that aspect

1 of it was part of our group.

2 SR. SPECIAL AGENT LUINA: And that's what
3 you had to work on and you're saying, like --

4 MR. SCHRULL: Yes.

5 SR. SPECIAL AGENT LUINA: -- why didn't we
6 just ask for it?

7 MR. SCHRULL: Yes.

8 SR. SPECIAL AGENT LUINA: Did you agree
9 with that concern? Is that -- was that a legitimate
10 issue that she was bringing up, or.

11 MR. SCHRULL: Sure. But at that point, it
12 was kind of water over the dam, you know --

13 SR. SPECIAL AGENT LUINA: okay.

14 MR. SCHRULL: -- you can't go back in time
15 --

16 SR. SPECIAL AGENT LUINA: Okay.

17 MR. SCHRULL: -- and perform the
18 surveillances. Why didn't they do them? Well, that's
19 -- that wasn't -- I -- I couldn't go and say gee, why
20 didn't you perform these surveillances because I'm not
21 privy to their work management schedule or anything
22 like that, so.

23 SR. SPECIAL AGENT LUINA: Okay. All
24 right.

25 MR. SCHRULL: But that wasn't a condition

1 of angst.

2 SR. SPECIAL AGENT LUINA: Okay. Are you
3 aware of any times when Ms. Henderson, for -- I guess
4 for lack of a better term, lied about the performance
5 of certain employees or that certain employees have
6 done certain things but they --

7 MR. SCHRULL: I'm not aware of her lying
8 about anything.

9 SR. SPECIAL AGENT LUINA: Okay. I ought
10 to say specifically, I guess -- I guess, maybe, you
11 know, you witnessed or you were aware -- I guess,
12 witnessed, first of all ask you, where maybe Henderson
13 was telling another manager either about Mc -- I don't
14 know who, but either about McBrearty or Wetzel,
15 particularly Wetzel, maybe, you know, accused them of
16 doing something that they hadn't done. You know,
17 dealing with performance issues or doing something
18 that's work related. Does that sound familiar at all?

19 MR. SCHRULL: No.

20 SR. SPECIAL AGENT LUINA: Okay. Okay.
21 Okay. Do you have any reason to question the -- the
22 integrity or trustworthiness of Ms. Wetzel? Beth
23 Wetzel?

24 MR. SCHRULL: Not at all.

25 SR. SPECIAL AGENT LUINA: Okay.

1 MR. SCHRULL: And I worked with her for
2 the six years I was there.

3 SR. SPECIAL AGENT LUINA: Okay.

4 MR. SCHRULL: And, once again,
5 intelligent, experienced, she was the licensing
6 manager at Sequoyah before I got there and very
7 competent.

8 SR. SPECIAL AGENT LUINA: And the same
9 about Mr. McBrearty. Any reason to question his
10 integrity or trustworthiness at all?

11 MR. SCHRULL: Absolutely not.

12 SR. SPECIAL AGENT LUINA: And I guess the
13 same with Ms. Hen -- Ms. Henderson?

14 MR. SCHRULL: No.

15 SR. SPECIAL AGENT LUINA: Did things
16 happen that --

17 MR. SCHRULL: No. You know, there's
18 always areas with all three where there are
19 disagreements. You know, we have professional
20 disagreements and -- and we have to get to a
21 reasonable resolution.

22 So -- but otherwise, integrity? Oh,
23 absolutely not.

24 SR. SPECIAL AGENT LUINA: Not a problem.
25 I guess Mr. Shea as well.

1 MR. SCHRULL: Oh, absolutely not.

2 SR. SPECIAL AGENT LUINA: Okay.

3 MR. SCHRULL: Yes.

4 SR. SPECIAL AGENT LUINA: Do you know why
5 Mr. McBrearty no longer words at TVA? Do you know.

6 MR. SCHRULL: I've heard but I --

7 SR. SPECIAL AGENT LUINA: Okay.

8 MR. SCHRULL: -- don't know. My
9 understanding was that there was an issue that -- and
10 here again, this is all hearsay --

11 SR. SPECIAL AGENT LUINA: Hearsay, yes.

12 MR. SCHRULL: -- that I've got. There was
13 an issue that he had with -- with Joe and Erin, but I
14 don't know what it was, I don't know why --

15 SR. SPECIAL AGENT LUINA: You weren't
16 involved in any of those discussions or --

17 MR. SCHRULL: No.

18 SR. SPECIAL AGENT LUINA: -- decisions or
19 meetings --

20 MR. SCHRULL: Oh, no, no.

21 SR. SPECIAL AGENT LUINA: -- because you
22 wouldn't -- you wouldn't be, obviously, because of
23 your role. Okay.

24 MR. SCHRULL: Yes.

25 SR. SPECIAL AGENT LUINA: Okay.

1 MR. SCHRULL: And I don't -- I'm not aware
2 of the particulars of his leaving. You know, it -- it
3 -- from our perspective and our meaning the
4 scuttlebut, if you will, is that, you know, he was on
5 vacation for a long time then all of the sudden he was
6 just not there.

7 SR. SPECIAL AGENT LUINA: Okay. You
8 didn't hear anything else about --

9 MR. SCHRULL: No.

10 SR. SPECIAL AGENT LUINA: -- what might
11 have led to his --

12 MR. SCHRULL: No.

13 SR. SPECIAL AGENT LUINA: -- leaving
14 happening? Okay. All right. All right, Ed. No, you
15 didn't hear about that. Was there anything I haven't
16 asked you about that you feel is relevant today? That
17 you would like to bring up about this issue? Either
18 about, you know, about corporate nuclear licensing in
19 gen -- in general or about Ms. Wetzel or Mr.
20 McBrearty?

21 MR. SCHRULL: No.

22 SR. SPECIAL AGENT LUINA: No?

23 MR. SCHRULL: I don't -- nothing in
24 particular.

25 SR. SPECIAL AGENT LUINA: Nothing in

1 particular, okay. Were there other people -- you said
2 there was Wetzell, you, was there other people that
3 were offered the same separation?

4 MR. SCHRULL: I don't know if Beth was
5 offered the same thing.

6 SR. SPECIAL AGENT LUINA: Oh, okay.

7 MR. SCHRULL: I don't know Mike --

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: -- or anyone else. I just
10 know my own particular situation.

11 SR. SPECIAL AGENT LUINA: You don't know
12 if the -- if they asked other managers that are --
13 that reported to Henderson to -- to leave as well, do
14 you know?

15 MR. SCHRULL: Yes, there was one other
16 lady -- oh boy -- and I don't remember her name. She
17 left -- she was there before Jim Polickoski. Oh boy.

18 SR. SPECIAL AGENT LUINA: O'Connor? Mitch
19 O'Connor (phonetic)?

20 MR. SCHRULL: Yes, thank you.

21 SR. SPECIAL AGENT LUINA: All right. All
22 right. That would be -- that was a while back,
23 though.

24 MR. SCHRULL: Yes, it was.

25 SR. SPECIAL AGENT LUINA: That was before

1 Jim, okay. That was like --

2 MR. SCHRULL: Five --

3 SR. SPECIAL AGENT LUINA: 2016

4 probably --

5 MR. SCHRULL: Yes.

6 SR. SPECIAL AGENT LUINA: -- or '15 or

7 something, yes.

8 MR. SCHRULL: Four years ago.

9 SR. SPECIAL AGENT LUINA: Okay.

10 MR. SCHRULL: That's three years ago.

11 SR. SPECIAL AGENT LUINA: Yes.

12 MR. SCHRULL: Okay.

13 SR. SPECIAL AGENT LUINA: Were you aware

14 -- because you've been there since 2013 --

15 MR. SCHRULL: Right.

16 SR. SPECIAL AGENT LUINA: -- were -- it's

17 been portrayed to me also through some other

18 interviews that there was some -- there was some

19 problems throughout all of corporate -- corporate

20 nuclear licensing.

21 A former manager that was there, another

22 former NRC guy, I guess. Does that sound familiar to

23 you at all?

24 MR. SCHRULL: Pete Wilson?

25 SR. SPECIAL AGENT LUINA: No.

1 MR. SCHRULL: No?

2 SR. SPECIAL AGENT LUINA: Gene Colby
3 (phonetic). Were you there --

4 MR. SCHRULL: Okay. Gene Colby?

5 SR. SPECIAL AGENT LUINA: Yes, were you
6 there for --

7 MR. SCHRULL: Yes, I was.

8 SR. SPECIAL AGENT LUINA: Okay.

9 MR. SCHRULL: I worked for him for a short
10 period of time.

11 SR. SPECIAL AGENT LUINA: Okay. Because
12 he -- he probably left in '13 or '14 I think, right?

13 MR. SCHRULL: Yes, it was more like '14,
14 '15. But anyway --

15 SR. SPECIAL AGENT LUINA: Is there -- is
16 there any truth to that though? Was there a --

17 MR. SCHRULL: Gene -- Gene was a
18 tough --

19 SR. SPECIAL AGENT LUINA: -- a bad --

20 MR. SCHRULL: -- guy to work for.

21 SR. SPECIAL AGENT LUINA: -- environment.
22 Okay.

23 MR. SCHRULL: But, you know, he was a real
24 straight shooter, but he was tough.

25 SR. SPECIAL AGENT LUINA: Okay. All right.

1 MR. SCHRULL: I didn't particularly have
2 a good time working for Gene.

3 SR. SPECIAL AGENT LUINA: Okay.

4 MR. SCHRULL: But that's just --

5 SR. SPECIAL AGENT LUINA: That's fine.

6 MR. SCHRULL: -- that's more of a
7 personality thing than a --

8 SR. SPECIAL AGENT LUINA: Yes.

9 MR. SCHRULL: -- because, once again, his
10 -- I didn't see anyone that we've talked about --

11 SR. SPECIAL AGENT LUINA: Yes.

12 MR. SCHRULL: -- who had a -- a slant or
13 not being on the side of nuclear safety which is, you
14 know, in -- in my -- my first position at Westinghouse
15 Hanford was in nuclear safety and throughout my
16 career, that's, you know, if we've got something --
17 you mentioned about bringing up issues, if we've got
18 an issue, we bring it up.

19 You know, it doesn't matter where it
20 falls. You know, this -- this is the thing that we --
21 and we pride our -- is like -- my position on nuclear
22 licensing is we are the final bastion to ensure that
23 this is a safely operated, you know, facility.

24 SR. SPECIAL AGENT LUINA: Okay. I know
25 you said she mentioned to you during your -- when they

1 -- when they offer -- made that offer to you about
2 some performance issues --

3 MR. SCHRULL: Yes.

4 SR. SPECIAL AGENT LUINA: -- are you aware
5 of other -- based on your -- I know you said you
6 disagreed with her assessment of that, obviously, were
7 there other departments in corporate nuclear licensing
8 or groups that you did think were low performing or
9 not performing up to their standards, I guess, based
10 on your -- what you witnessed and what you knew about
11 I guess, in your experience?

12 MR. SCHRULL: There was -- we had a -- to
13 me, we had a really good high performing group.

14 SR. SPECIAL AGENT LUINA: Okay.

15 MR. SCHRULL: We had good experience and
16 -- and everyone that was there. So, I wouldn't say
17 that anyone was "a low performer."

18 SR. SPECIAL AGENT LUINA: Okay.

19 MR. SCHRULL: We had some people who
20 brought up issues and we dealt with them.

21 SR. SPECIAL AGENT LUINA: Okay.

22 MR. SCHRULL: So --

23 SR. SPECIAL AGENT LUINA: Okay. Okay.
24 Well, that's good. I got some questions I need to ask
25 you here at the end that we ask everyone we interview.

1 MR. SCHRULL: Okay.

2 SR. SPECIAL AGENT LUINA: And then I'll
3 give you an opportunity again to add anything if you
4 want to.

5 I need to ask you, sir, have I or any
6 representative of the NRC threatened you in any manner
7 today?

8 MR. SCHRULL: Absolutely not.

9 SR. SPECIAL AGENT LUINA: Have you been
10 offered any reward or compensation in return for the
11 information that you have provided during this
12 interview?

13 MR. SCHRULL: No.

14 SR. SPECIAL AGENT LUINA: Have you
15 provided the information freely and voluntarily?

16 MR. SCHRULL: Yes.

17 SR. SPECIAL AGENT LUINA: Is there anything
18 else you'd like to add for the record at this time?

19 MR. SCHRULL: No.

20 SR. SPECIAL AGENT LUINA: Nothing else?
21 All right. Well, I appreciate it, Ed. And if there's
22 nothing else, the time is now 9:37 a.m. on May the
23 23rd, 2019 and this interview is over.
