Dear Administrative Judges:

Pursuant to the Atomic Safety and Licensing Board's "Order (Granting Joint Motion Regarding Disclosures)," dated February 8, 2021, the staff of the U.S. Nuclear Regulatory Commission ("Staff") herein notifies the Licensing Board and the parties that NRC staff's initial disclosures have been provided for this proceeding.
