## <u>ORDER</u>

On August 21, 2020, the Atomic Safety and Licensing Board issued an initial decision on a challenge by C-10 Research and Education Foundation (C-10) to a license amendment request filed by NextEra Energy Seabrook, LLC related to the operating license for Seabrook Unit 1.<sup>1</sup> The Board found that the license amendment, with the addition of four license conditions, provided reasonable assurance of adequate protection.<sup>2</sup> C-10 filed a motion to reopen the record for consideration of supplemental testimony, a motion for leave and a motion for partial reconsideration, and a motion for leave to reply to oppositions to its motion for partial reconsideration.<sup>3</sup> On November 6, 2020, the Board denied C-10's motions, except that it granted its motion for leave to reply for a limited purpose.<sup>4</sup> None of the parties appealed either
