Dear Mr. Voorhies:

By letter dated October 26, 2020 (available in the U.S. Nuclear Regulatory Commission's [NRC] Agencywide Document Access and Management System [ADAMS] at Accession No. Main Library [ML] ML20304A123), Water Remediation Technology, LLC (WRT) submitted to the NRC a request for written consent to an indirect transfer of control of NRC Materials License Number SUC-1591. In accordance with Section 184 of the Atomic Energy Act of 1954, as amended (AEA), and 10 Code of Federal Regulations (10 CFR) 40.46, the NRC consents to the transfer. On February 23, 2021, NRC staff provided written approval of WRT's request for indirect transfer of control (ADAMS Accession No. ML21029A196). I requested notification from WRT once the transfer was complete in order to finalize the administrative changes proposed in the draft license enclosed in the written approval. As indicated in the written approval, the administrative changes reference WRT's transfer of control application and response to NRC's request for additional information. On March 8, 2021, WRT notified NRC that the transfer was complete (ADAMS Accession No. ML21068A301). I have enclosed Amendment 1 of Source Material License No. SUC-1591.
