This refers to your license amendment request dated January 5, 2021. Please find enclosed Amendment No. 10 authorizing the change in radiation safety officer (RSO). We do not list alternate RSOs on the license for portable gauge licenses; as such, the name of the alternate RSO is not shown on the license. Finally, several license conditions were updated to the new standard license conditions as detailed in NUREG-1556 Volume 20, Revision 1, "Consolidated Guidance About Materials Licenses: Guidance About Administrative Licensing Procedures".

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
