Subject: Three Mile Island Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, Revision 23

Pursuant to 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (Exelon) is submitting Revision 23 to the Three Mile Island Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan. Changes to this document were implemented on January 21, 2021. In accordance with 10 CFR 50.54(p)(2), Exelon is submitting these changes within 60 days of implementation (i.e., no later than March 22, 2021).

The changes in Revision 23 were made to align with the Three Mile Island Unit 1 implementation of License Amendment 301 "Removal of Cyber Security Plan License Condition" issued on December 4, 2020 (ML 20297A627).

Exelon has concluded that the changes do not decrease the safeguards effectiveness of the Three Mile Island Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.

Attachments 1 and 2 contain Safeguards Information. Therefore, Exelon requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (d)(1), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).


