This refers to your license amendment requests dated January 13, 2021, January 20, 2021, and February 5, 2021. Please find enclosed Amendment No. 54 authorizing the removal of the seed storage room and the old cardiology suite from your license and the approval for the new cardiology suite. The removed areas may be used for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
