Following presentations from the NRC and Entergy, members of the public will have the opportunity to ask questions regarding the NRC's assessment of the station's safety performance.

Purpose: This is a public meeting between the NRC and Entergy Operations, Inc., to present the results of the NRC's annual assessment of safety performance at the Grand Gulf Nuclear Station (GGNS) for the calendar year 2020.
