The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed the letter dated October 27, 2020, requesting approval of a classified network change and revision of associated information system security plans. We have concluded that the proposed change is acceptable. Pursuant to Part 70 of Title 10 of the *Code of Federal Regulations* (10 CFR), Materials License SNM-2010, Condition 10 is hereby amended to read to as follows:

- 10.aa Deleted per Amendment 82.
- ab URENCO USA Facility, Classified Operations System Information System Security Plan (UUSA-COS-ISSP), Revision 0.
- ac Deleted per Amendment 89.
- ad URENCO USA Facility, Enhanced Training System Information System Security Plan (UUSA-ETS-ISSP), Revision 5.
- ae URENCO USA Facility, Information System Security Baseline Common Control Catalog, Revision 3.

In addition, a typographical error has been corrected by amending Condition 10.af to read as follows:

- 10.af Decommissioning Financial Assurance submitted by letter dated December 12, 2019 and revised by e-mail dated April 2, 2020 and letter dated October 12, 2020.
