Enclosed is Amendment No. 71 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-18585-01 in accordance with your January 25, 2021, and March 8, 2021 letters. As requested, several changes, including to remove the listed Associate Radiation Safety Officer, to add an Authorized User, and to remove the nuclear medicine facility listed at the 801 Joe Mann location of use listed on the license. Your requests are available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession Nos. ML21034A445 and ML21083A232, respectively.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

The NRC staff has reviewed your final status surveys for the 801 Joe Mann Blvd., Midland, Michigan location of use. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material at the 801 Joe Mann Blvd. location of use. Your facilities at 801 Joe Mann Blvd., Midland, Michigan, are suitable for unrestricted use.

The enclosure to this letter contains sensitive security-related information. When separated from this cover letter this letter is uncontrolled.
