Dear Mr. Wagner:

Enclosed is Amendment No. 2 renewing your NRC Material License No. 13-32808-01 in accordance with your request.

Please note that the format of your license has changed due to our new license processing system. Additionally, several conditions have been updated in accordance with NRC licensing policy. Specifically, Condition 11 has been updated to include the requirement that records of be maintained for three years for individuals designated as users of the gauge. Condition 13 A. has been updated to include the requirement that in the absence of a registration certificate the interval for leak testing of the gauge is not to exceed six months. Condition 15 has been updated to include the requirement that records of physical inventories must be maintained for three years after they are conducted. Additionally, Conditions 19.A. and 19.B., as described on Amendment No. 1, have been deleted as they are not applicable to the types of material authorized on the license. Lastly, Condition 20, as described on Amendment No. 1, regarding transportation requirements has been deleted as these requirements are already specified in the regulations in 10 CFR Part 71.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
