DISCUSS TOPICAL REPORT IMPLEMENTATION AND OVERSIGHT

On March 22, 2021, a closed virtual meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Westinghouse Electric Company (Westinghouse) representatives. The meeting was closed due to the proprietary nature of the information discussed. The purpose of the meeting was to give Westinghouse an opportunity to provide proprietary feedback on the February 4, 2021, public meeting that introduced the conceptual topical report implementation and oversight (TRIO) process and to assess any interest in being involved with a potential pilot program for TRIO.
